Pymble Station Upgrade

Transport for NSW | September 2022

The Pymble Station Upgrade is part of the Transport Access Program, a NSW Government initiative to provide a station that is accessible to people with a disability, limited mobility, parents / carers with prams, and customers with luggage. We thank you for your patience during this important work.

What's next at Pymble in September?

Throughout September, work will include:

- fit-out of new lifts
- installing electrical services within and around the station
- public domain work in front of the station entrance on Pacific Highway involving the upgrading of the footpath.

Upcoming work in September

Work will continue **Monday to Friday from 7am until 6pm**, and from **8am until 1pm on Saturdays**.

We will be working outside of standard construction hours over the following periods:

- **From 6pm Wednesday 7 September to 5am Thursday 8 September**, we will be working on Avon Road and the Pacific Highway to carry out pole modification work.
- **From 6am Saturday 17 September to 10pm Sunday 18 September**, we will be working in the Pacific Highway carpark installing new cable routes, and upgrade fencing.
- **Between 8pm and 5am Monday 26 September to Friday 30 September**, we will be working in and around the station to carry out electrical work.

We will notify businesses and residents of the work closer to the date.

Pacific Highway temporary bus stop relocation

The bus stop on the Pacific Highway next to Pymble Station (**Stop ID 207311**), will be relocated around 30 metres south on the Pacific Highway **from Thursday 1 September to Friday 23 September** to allow for footpath upgrades to be carried out.

Pacific Highway temporary lane closure

Temporary lane closures of the kerbside northbound lane and the kerbside southbound lane on the Pacific Highway will be in place **from 8pm Wednesday 7 September to 5am Thursday 8 September** to allow for pole works. Traffic control and signage will be in place to provide directions to motorists.

Pacific Highway temporary car park closure

The carpark off Pacific Highway (as shown on the map on the next page) will be closed **from 5pm on Friday 16 September until 11pm on Sunday 18 September**.

This closure will allow for the installation and connection of new services, car park regrading and installing new fence panels. Traffic control will be in place to safely manage the work area during this period.



How this work may affect you

Our work throughout September will use a range of equipment including excavators, vacuum trucks, road saws, tipper trucks, flatbed trucks, tilt trays, concrete trucks and pumps, elevated working platforms, lighting towers, dump trucks, jackhammers, work vehicles, augers, grinders, chain saws, chippers, cranes, and various hand and power tools.

Our work will be noisy at times. Where possible, measures will be implemented to reduce noise and dust associated with these works, including adding shade cloth mesh to fencing, turning off equipment when not in use, placing equipment as far away as possible from properties and using non-tonal reversing beepers.

Changes to scheduled work

Work schedules are subject to change due to permits, weather, and site conditions. Further notification will be provided should there be

significant changes to the construction program.
