

# Commuter Car Park Program: Warwick Farm

# **Community Notification – June 2022**

Transport for NSW has delivered 250 new car parking spaces for commuters at Warwick Farm Station as part of the NSW Government's Commuter Car Park Program. Construction is now complete on the multi-storey commuter car park at Warwick Farm Station and new levels are open.

# Repair and resurfacing of the external commuter car park from June 2022

Subject to approval, around 150 parking spaces at the location indicated below will be temporarily unavailable for approximately two months from early June 2022. This is to allow for repair and resurfacing of a large section of the car park pavement.

Vehicle access to the multi-storey car park will be via Remembrance Avenue only. Pedestrian access around the work area will be maintained at all times.

Work will include excavation, removal and delivery of pavement materials, compacting and laying of asphalt and line marking. Equipment and plant will include asphalt machines, excavators, trucks, rollers, compactors, line marking equipment and hand tools.

There may be some noise associated with this work. Wherever possible, measures to reduce noise will be implemented including scheduling noisy work during daytime hours, turning off vehicles and equipment when not in use, monitoring noise, using non-tonal beepers and acoustic barriers.

# **Construction hours**

Construction hours are 7am to 6pm Monday to Friday and 8am to 1pm Saturdays. Work is subject to weather, site conditions and COVID restrictions and may change without notice.
