Project Update – March 2022

Transport for NSW is delivering additional commuter parking at Warwick Farm to provide the community with more convenient access to public transport and reduce congestion on our roads. The project includes adding two levels to the existing multi-storey commuter car park to provide approximately 250 additional commuter parking spaces. Construction of the additional levels is nearing completion.

Progress update

The Ground level and Levels 1 and 2 of the multi-storey car park are open to the public for use. Level 3 remains temporarily closed to allow work to continue safely. Construction of Level 4 and Level 5 is nearing completion. Levels 3, 4 and 5 along with the stairs and lifts are expected to be opened to the public in late March 2022 subject to weather, site conditions, and COVID restrictions.

In the past month, the final concrete pours were undertaken, the tower crane and its foundations were removed from site and scaffolding has progressively been removed. The solar canopies on Level 5 and electrical systems were commissioned and the façade work was completed.

Construction hours

All work is subject to weather, site conditions and COVID restrictions, and may change without notice. Construction hours are 7am to 6pm Monday to Saturday, however we may also need to work from 9am to 5pm on Sundays. These extended construction hours are approved by the NSW Government under special provisions during the COVID pandemic. Thank you for your patience during this important work.

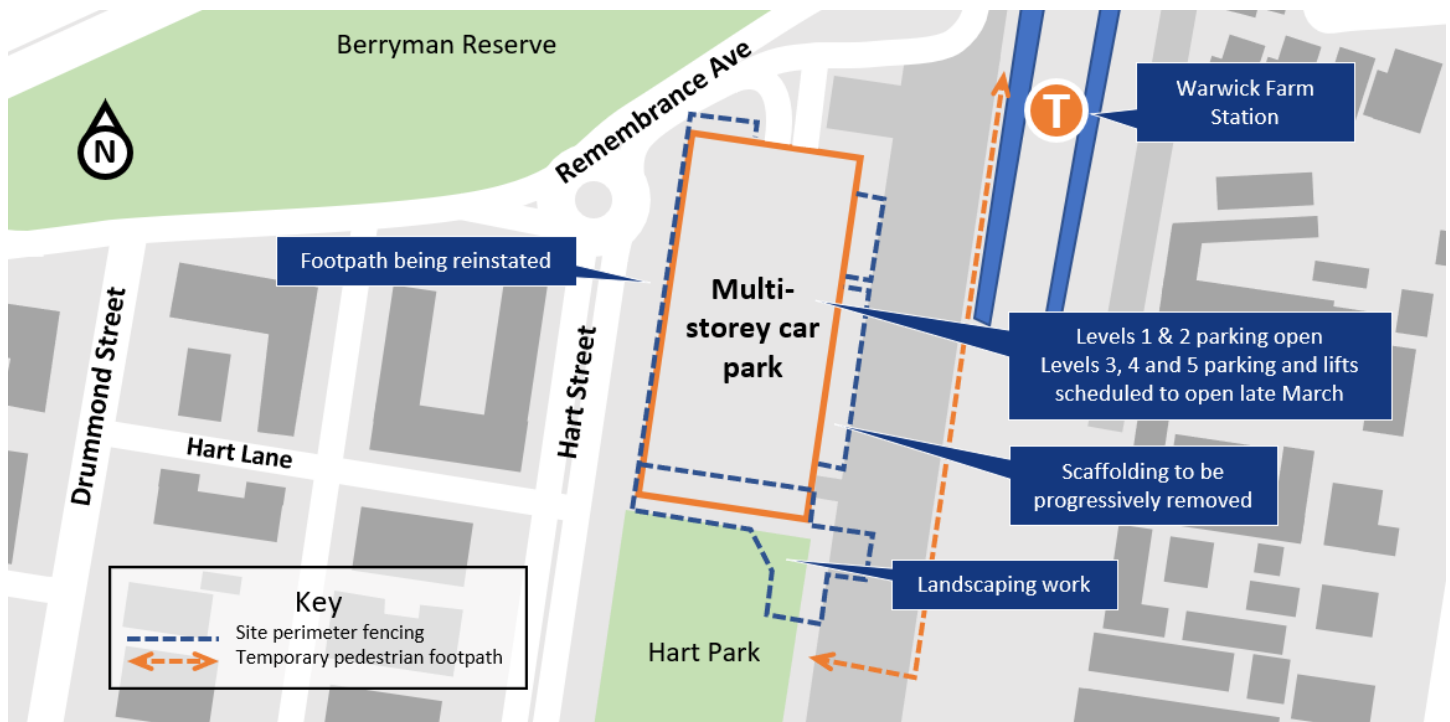
Upcoming work in March

- Commissioning of the lifts
- Painting and line markings on Levels 3, 4 and 5
- Installing the CCTV system and other services
- Removing scaffolding from around the perimeter of the car park structure
- Constructing footpaths and landscaping works around the multi-storey car park and in Hart Park.

Current parking restrictions

Through March, car spaces occupied for construction purposes will be progressively released for public use.
