



# **More Trains, More Services**

Wolli Creek Power Supply Upgrade and Canopies Project



## What are we doing in Wolli Creek?

Transport for NSW is building a new substation near Wolli Creek Station. This upgrade will create the necessary power supply to support the increase in the number of trains travelling along the T8 Airport line in the future.

We are also extending the platform canopy at Wolli Creek Station to increase weather protection and encourage customers to use the full length of the platform, reducing crowding at busy times.

#### What happened in March?

During March, we completed asbestos removal, excavation and backfill, and installation of service utilities. We also installed electrical service units and lighting power to the platform at Wolli Creek Station.

### What's planned next?

This month, the project team will carry out the following work:

- asbestos removal
- investigation and installation of service utilities
- piling work
- electrical services work
- installation of down pipes and bird proofing to new platform elements.

Standard construction hours on this project are **7am to 6pm** Monday to Friday, weekends and public holidays.

#### Where will work take place?

The map overleaf shows the location of work inside the rail corridor south of Wolli Creek Station with site access via Lusty Street.



# Are there activities and deliveries planned outside standard construction hours?

Some work will be completed outside of standard construction hours. The work will occur from 6am to 6pm:

Saturday 17 April and Sunday 18 April.

Scheduling work outside of standard construction hours enables the construction team to safely carry out essential activities inside the rail corridor.

This work is dependent on weather and site conditions and is subject to change.

Delivery of structures and equipment to and from site are scheduled to occur on:

- Friday 16 April from 10pm to 2am
- Tuesday 20 April from 3am to 5am.

This will include up to two trucks to remove precast concrete, a piling rig and a crawler crane from site via Lusty Street.

Residential street parking and side streets will remain open during the delivery, however there may be some temporary restrictions on access along Lusty Street for a period of no longer than 30 to 40 minutes during loading for each.

We don't expect this work to be noisy, and every effort being made to minimise disruption to the community including using non-tonal reversing alarms on all construction vehicles.

## How do we consider the community?

The project team understands construction activities may cause disruption for the community and we will seek to minimise impacts as much as possible.

When carrying out our work, the project team utilises a noise assessment of the programmed activities to determine the noise to be generated and the appropriate mitigation measures to be put in place. We will also continue to ensure we adhere to strict environmental conditions relating to vibration and dust management.
