

# Wolli Creek Power Supply Upgrade

More Trains, More Services

March and April 2023

*Transport for NSW pays respect to Elders past and present, and recognises and celebrates the diversity of Aboriginal peoples and their ongoing cultures and connections to the lands and waters of NSW.*

We are upgrading the power supply to support the introduction of the new fleet of trains operating along the T8 Airport Line. It will also future-proof the connection to the Sydney Trains network, allowing more trains and services to be available to customers. Upgrades to the power supply are along the T8 Airport Line tunnel from Central to Wolli Creek Junction.

## What work are we doing in your area?

In March and April 2023 the Wolli Creek Power Supply Upgrade project team will undertake the following activities:

- continuing to fit out the substation and installing new fencing around the substation boundary
- installing cables, metal fixings and other electrical infrastructure inside the rail corridor near Spark Lane to connect power from the substation to the track
- installing overhead wiring infrastructure within the rail corridor near the Wolli Creek Station footbridge.

## When and where we'll be working

Standard construction hours are **7am to 6pm, Monday to Friday and 7am to 1pm on Saturdays.**

We'll be working inside the rail corridor and within the site compounds located at 5A and 25 Lusty Street. The map overleaf outlines locations of the work and site access points.

## Out-of-hours work

Some work will take place outside of standard construction hours from

- **12am to 7am Friday 10 March 2023**
- **12am to 7am Tuesday 14 March 2023**
- **10pm Friday 31 March through to 5am Monday 3 April 2023.**

Out-of-hours work will take place during scheduled Sydney Trains trackwork periods when no trains will be running. Scheduling construction work outside of standard construction hours enables our project team to complete the activities safely. All construction work is weather permitting and subject to change.

## What will this mean for you?

During construction, you may notice the following:

- increased workers and vehicles in and near the site compounds
- noise from machinery and equipment.

## Managing our impacts

We understand construction activities may cause disruption for the community. We will seek to minimise impacts as much as possible and adhere to strict environmental conditions relating to noise, vibration and dust management.
