Resolution in Relation to Out of Session Business Item 2013/13

On 2 April 2013 the City of Sydney, in its capacity as a Parking Authority under section 51M of the *City of Sydney Act 1988*, notified the CSTTC of a proposal to reallocate one unrestricted parking space on the northern side of Belvoir Street, east of Elizabeth Street, to a dedicated parking space for car share.

- **Notes** the proposal includes the reallocation of one unrestricted parking space to car share parking on the northern side of Belvoir Street, Surry Hills.
- **Agrees** pursuant to section 51M(1) of the *City of Sydney Act 1988* to 10 days as the lesser period within which particulars of the proposed works are required to be forwarded to the CSTTC before the proposed commencement of the works.
- **Resolves** not to issue any direction to the Council of the City of Sydney pursuant to section 51M of the *City of Sydney Act 1988*
