1. Introduction

1.1. Background

Roads and Maritime Services (Roads and Maritime) are extending the M1 Princes Motorway between Yallah and Oak Flats to bypass Albion Park Rail. The motorway would complete the 'missing link' for a high standard road between Sydney and Bomaderry. The project is known as the Albion Park Rail bypass (Stage 2 – Princes Motorway between Yallah and Oak Flats) (the Project).

This Pre-Construction Compliance Report (PCCR) has been prepared in accordance with the Compliance Tracking Program (CTP) required under the Minister's Conditions of Approval (CoA) A25 and A26.

1.2. Purpose

The purpose of this PCCR is to address the requirements of CoAs A28 and A29, which are listed in Table 1-1 below. A cross reference is also included to indicate where each condition requirement is addressed in this PCCR.

1.3. Approval documentation

2. Pre-construction compliance

2.1. Conditions of approval compliance table

Details of how each CoA applicable to Stage 2 of the Project has been complied with is provided in the compliance table attached at Appendix A. The table in Appendix A identifies:

- each condition of approval
- the applicability of the CoA to Stage 2 (as defined in the Staging Report under CoA A12)

Evidence of compliance can be submitted to the Secretary upon request.



The evidence presented in Appendix A demonstrates that all conditions of approval relevant to commencement of works for Stage 2 are compliant.

2.2. Date of commencement of works

The date of commencement of works for the Project is 2 November 2018.

Works will not commence until the PCCR has been submitted to the Secretary for information no later than one month before the commencement of works or within another timeframe agreed with the Secretary.
