BACKGROUND

The Albion Park Rail Bypass (APRB) received State Significant Infrastructure project approval under Section 115ZB of the *Environmental Planning & Assessment Act 1979* on 30 January 2018, subject to conditions.

This letter provides an update on the delivery of the APRB Biodiversity Offset Package (BOP) and specifically addresses Condition of Approval Part E (E12) which states;

The Proponent must submit a progress report to the Secretary which identifies offsets required and evidence that they are achievable, or alternatively provide details on how the offset requirements will be met using the Biodiversity Conservation Fund. This report must be provided to the Secretary for information prior to any impacts on vegetation communities and the Eastern Flame Pea endangered population, except those within the Croom Regional Sporting Complex.

As part of the project approval requirements as outlined in the approved Biodiversity Offset Strategy (BOS) (ngh environmental, March 2017) and Biodiversity Addendum (ngh environmental, December 2017), biodiversity offset is required as assessed under the Framework for Biodiversity Assessment (FBA) 2014 as outlined in Table 1.

BIODIVERSITY OFFSET LEGISLATIVE REQUIREMENTS

The project approval was subject to biodiversity offsets in accordance with FBA 2014. The project approved Biodiversity Offset Strategy (BOS) was also prepared in accordance with the FBA and sets out the pathway forward to securing and managing the final biodiversity offsets subject to trading rules set out under the FBA and the Biodiversity Offsets Policy for Major Projects 2014.

NSW legislative changes that came into effect on 25 August 2017 repealed the *Threatened Species Conservation Act 1995* and enacted the *Biodiversity Conservation Act 2016* (BC Act). This legislative change has led to the removal of both the FBA and BioBanking Assessment Methodology 2014 (BBAM) and replaced these with the Biodiversity Assessment Method 2017 (BAM). In terms of establishing biodiversity offset sites in NSW, the BAM has replaced BioBanking Agreements with Biodiversity Stewardship Agreements and as such all biodiversity credit calculations are now subject to the BAM and associated credit calculator.

Part of the project biodiversity offset delivery will be establishing sites which are proposed to be secured through Biodiversity Stewardship Agreements using the BAM and enforced under the BC Act. Given this will result in using a different method and subsequent credit yield to the project applied FBA and BBAM, the credits for each site have also been calculated using the former assessment methodologies to ensure equivalence of credits being retired for the project.

To ensure the final offsets for the project provide equivalence in respect to these different methods, Roads and Maritime lodged a formal application for reasonable equivalence of biodiversity credits for the projects existing offset obligation on the 5th of June, 2018 to the Office of Environment & Heritage and is currently awaiting response.

OFFSET NEGOTIATIONS WITH LANDHOLDERS

Roads and Maritime has been actively pursuing offset sites with both Shellharbour City Council and NSW Tafe. In regards to the negotiations with Shellharbour City Council, Roads and Maritime has undertaken negotiations on Part A management costs and made an offer of compensation for the Part B component of the offset. On the 22 May 2018 a business paper including a number of offset sites was debated by Shellharbour City Council at an ordinary meeting. The Council resolved to pursue offsetting for Croom Reserve and Dunmore Wetlands (Site 1 and Site 22 of the BOS), this is provided in Appendix A.

Negotiations are progressing well to secure the Yallah Tafe offset site, and on the 15 March 2018 Roads and Maritime received an in principle agreement from NSW Tafe to undertake the offsetting for the Albion Park Rail bypass project (Appendix B). A joint appointed valuer has undertaken a valuation of the Part B costs of the offset and negotiations on Part A are continuing.

ACHIEVABILITY OF BIODIVERSITY OFFSETS

PCT 1326 (SR669) Woollybutt – White Stringybark – Forest Red Gum grassy woodland on coastal lowlands, southern Sydney Basin Bioregion and South East Corner Bioregion

In delivering the biodiversity offset obligation for PCT 1326, detailed field survey was undertaken on sites 1 and 23 of the BOS. These sites will deliver about 335 FBA ecosystem credits for this vegetation type and will be secured



through the establishment of Stewardship Agreements under the BC Act 2016. The equivalent of 335 FBA ecosystem credits will be retired against the project from these stewardship sites. A summary of the credit yield for these sites using FBA/BBAM and BAM is provided in the Table 2.

The shortfall of 3 credits will likely be delivered through payment in to the Biodiversity Conservation Fund for this vegetation type based on the equivalency conversion.

In delivering the biodiversity offset obligation for PCT 838, detailed field survey was undertaken on sites 1 and 23 of the BOS. These sites will deliver more than the required 18 credits for this vegetation type and will be secured through the establishment of Stewardship Agreements under the BC Act 2016. The equivalent of 18 FBA ecosystem credits will be retired against the project from these stewardship sites. A summary of the credit yield for these sites using FBA/BBAM and BAM is provided in *Table* 3.

PCT 1245 (SR652) Sydney Blue Gum x Bangalay - Lilly Pilly moist forest in gullies and on sheltered slopes, southern Sydney Basin Bioregion

Existing BioBanking credits are currently available on the public register for PCT 1245. A total of 350 FBA ecosystem credits established from two BioBank sites are currently listed. Negotiations on the purchase of these credits are ongoing. In the event these credits are unable to be purchased consideration will also be given to a payment in to the Biodiversity Conservation Fund to fulfil this offset obligation. A summary of the credits available on the public register for this vegetation type is provided in *Table 4*.

PCT 1232 (SR649) Swamp Oak floodplain swamp forest, Sydney Basin Bioregion and South East Corner Bioregion

In delivering the biodiversity offset obligation for PCT 1232, detailed field survey was undertaken on sites 22 and 23 of the BOS. These sites will deliver more than the required 18 FBA ecosystem credits for this vegetation type and will be secured through the establishment of Stewardship Agreements under the BC Act 2016. The equivalent of 18 FBA ecosystem credits will be retired against the project from these stewardship sites. A summary of the credit yield for these sites using FBA/BBAM and BAM is provided in *Table 5*.

PCT 781 (SR536) Coastal freshwater lagoons of the Sydney Basin Bioregion and South East Corner Bioregion

In delivering the biodiversity offset obligation for PCT 781, detailed field survey has been undertaken on site 22 of the BOS. This site will deliver 154 equivalent BBAM credits of the required 293 FBA ecosystem credits through the establishment of Stewardship Agreements under the BC Act 2016. A summary of the credit yield for this site using BBAM and BAM is provided in *Table 6*.

The shortfall of 139 FBA ecosystem credits will likely be delivered through payment in to the Biodiversity Conservation Fund for this vegetation type based on the equivalency conversion for the project.

Chorizema parviflorum (Eastern Flame Pea)

In relation to species credit availability for *Chorizema parviflorum* (Eastern Flame Pea) targeted surveys were conducted on sites 1 and 23 of the BOS. These surveys were conducted during the 2017 flowering period for this species (November). A total of 1,022 species credits (BBAM) will be generated from these two sites. This will leave a shortfall of about 703 credits.

The short fall in available credits is partly due to the limited distribution of this species in the locality and that the preferred offset site identified in the BOS, site 8 (Transgrid), withdrew interest in establishing an offset site for this species (Appendix C).

Considering this, FBA variation rules and BAM trading rules allow for offsetting a threatened flora species with another threatened flora species that is of the same threat level and in the case of FBA, of the same life form. It has been discussed with OEH that an option for offsetting the Eastern Flame Pea could be through the purchasing and retirement of species credits for the BC listed endangered shrub *Zieria granulata*. Both species are listed as endangered under the BC Act and are classified as shrubs in the Threatened Species Profile Database.

In relation to *Zieria granulata*, Roads and Maritime has applied to establish a BioBanking Agreement (BA 417) for a site in Broughton that is within the Illawarra IBRA subregion. This site is expected to generate about 3,536 FBA/BBAM species credits of the endangered shrub (*Zieria granulata*).

In accordance with species credit variation rules under FBA, it is proposed that of these credits generated for *Zieria granulata* on BA 417, Roads and Maritime will retire credits to fulfil the residual shortfall of the Eastern Flame Pea offset requirements.

Should there be a problem with the sourcing of these credits Roads and Maritime could satisfy the species credit offset obligation through payment in to the Biodiversity Conservation Fund. A summary of the credit yield for these sites using FBA/BBAM and BAM is provided in *Table* 7.

CONCLUSION

The delivery of the project BOS is well advanced and generally follows the commitments outlined in the approved BOS. As highlighted above, the offsets will deliver the majority of the obligations as direct offsets through the retirement of a combination of BBAM and BAM credits. Any credit deficiencies will be met through payment into the Biodiversity Conservation Fund, this will be done so based on the outcome of the assessment of reasonable equivalency for the project offset obligations.

Given this approach and considering the recent legislative changes, the delivery of the offsets rely upon determination and issuing of a statement of reasonable equivalence by the Office of Environment & Heritage to enable the purchase of credits in accordance with the BC Act.

The information provided in this memo identifies offsets required and evidence that they are achievable as required under Condition E12 of the approval. Roads and Maritime will continue to progress the project BOS in consultation with relevant government agencies.

IN-PRINCIPLE APPROVAL TO AN AGREEMENT TO EXCLUSIVELY PURCHASE BIOBANKING CREDITS

Dear Mr Fayers,

On the 17th of August 2017, your wrote to TAFE NSW seeking our in-principle approval to an agreement to exclusively purchase credits generated from the possible biobanking of a parcel of land on our Yallah Campus. This agreement is subject to an assessment of the site by RMS to ensure that the site generates the number and type of biobanking credits that RMS need to address their requirements in relation to the Albion Park Rail Bypass project.

Having examined the proposal along with supporting information I am prepared to provide inprinciple approval to developing that agreement subject to the following criteria.

- The appointment of any authorised party to conduct the biobanking assessment, make the application, or conduct any related activities (e.g. land valuations) will be subject to our agreement;
- All documentation including supporting documentation relating to the biobanking
 assessment, report, application or any other documentation relating to this process will be
 supplied to TAFE NSW which will have the right to retain the documentation irrespective
 of the outcome of this process.

As has previously been agreed all costs relating to the developing the biobanking agreement, management plans, developing and submitting applications and any related fees or charges will be paid for entirely by RMS. RMS also agree to address in part any charges that TAFE NSW incur in relation to the review of the biobanking agreement or the agreement with RMS to exclusively purchase credits.

Please note that this in-principle approval should not be considered an undertaking to enter into a contract either expressed or implied. Any agreement including the biobanking agreement or the agreement to provide the RMS with biobanking credits exclusively will be subject to our review and an agreement will only exist when a contract has been executed by both parties.

Sorry I missed your call yesterday. Brianna indicated that you had some questions about the biodiversity matter. I have attached the most recent RMS factsheet.

If Transgrid (and partners) were to proceed the matter would be noted on title in perpetuity and there would be an obligation to carry out (funded) "management actions" in perpetuity. There would be no potential for future development of the land.

I guess that the most pressing matter for RMS is to secure the land required for the Princes Highway and Transgrid's concurrence to proceed with this acquisition as compulsory by agreement (VG determination) would be greatly appreciated. This is our first and essential priority. It is understood that the biodiversity matter is optional for Transgrid and somewhat complicated by the ownerships and lease arrangements together with your consideration as to whether the land may be required for future expansion of the facility.
