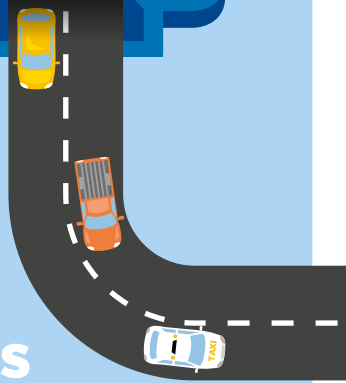




Cammeray noise mitigation solutions

Project Update



The NSW Government is committed to delivering solutions that will reduce traffic noise for people living in Armstrong, Massey and Jenkins Streets, Cammeray.

Roads and Maritime Services has been engaging with the community about noise mitigation solutions for your area. We understand this process has taken some time and we thank you for your patience.

We value your input and after considering all community feedback, we are proposing three different noise mitigation solutions for the area.



1. Massey to Amherst Street

The Massey to Amherst Street Noise Wall would be around four metres high by 175 metres long. The construction of this wall is complex due to its location. As a result we need to carry out further investigations and design work, which requires a longer time period in comparison to the Amherst Street Noise Wall. This will also ensure it can be built with the least impact to the community.

This option requires agreement from all residents who live close to the proposed noise wall. We have been meeting with impacted residents and are working as efficiently as possible to progress this noise wall.

2. Amherst Street Noise Wall

This noise wall would measure about four metres high by 70-80 metres long. If approved, we expect construction to start mid-2020, which would take around ten months to build.

3. At property treatment

At-property treatments aim to reduce noise inside eligible properties by replacing doors, windows, seals and/or installing a ventilation system.

Eligible properties will be assessed around October this year and we aim to complete all at-property treatments by mid-2020. We will be in touch later this year to organise a property inspection.

The eligibility criteria must be met and more information can be found at rms.nsw.gov.au/nap.

Both the Amherst Street Noise Wall and at-property treatments would be delivered in advance of the Massey to Amherst Street Noise Wall, while investigations and planning continues.

Together, these three solutions will reduce the impact of noise in the Cammeray area.

Next steps

1. Massey to Amherst Street Noise Wall (investigation)

- 1 Continue meeting with impacted properties and collating their feedback
 - 2 Carry out site investigations
 - 3 Inform the community of the progress and outline the next steps.
- This option will only proceed with agreement from all impacted owners. This process will take some time to complete. We will inform you once the outcomes of these investigations are confirmed.

2. Amherst Street Noise Wall

- 1 Carry out site investigations
- 2 Complete the Concept Design
- 3 Hold a community feedback session (Q3 2019)
- 4 Invite the community to submit feedback on the Concept Design.

We will continue to keep you informed as this project progresses.

3. At-property treatment

- 1 Eligible properties will be assessed around October this year. We will be in touch to organise a property inspection.
- 2 We aim to complete all at-property treatments by mid-2020.
