

# New pedestrian safety measures on Anzac Parade, Maroubra

## Start of work

## Transport for NSW | April 2020

From **Tuesday 5 May 2020**, Transport for NSW will begin work to establish new pedestrian safety measures on Anzac Parade, Maroubra, between Maroubra and Boyce roads.

The work (see figure) involves the installation of a 40m pedestrian fence on Anzac Parade's northbound carriageway, the closing of pedestrian access points adjacent the median public carpark, and the creation of new 'No Stopping' zones. (The 'No Stopping' zone on the right lane approaching Boyce Road will involve the removal of 11 parking spaces.)

Work is expected to take six shifts over a two week period. Nearby bus stops will be temporarily moved a short distance from their present location. Signs on existing bus stops will direct people to the new locations. There will be some disruption to traffic and pedestrian access while the work is completed.

The new measures aim to reduce or eliminate collisions involving pedestrians and motor vehicles. There were five serious incidents requiring hospitalisation of pedestrians in the area between 2014 and 2018.



#### Our work schedule

Work to complete the new pedestrian safety measures will take place over two day shifts and four night shifts, between **Tuesday 5 May** and **Thursday 21 May**, weather permitting.

Our day shifts are **Monday to Friday** between **7am and 5pm** and **Saturdays** between **8am and 1pm**.

Our night shifts are **Sunday to Thursday** between **8pm and 5am.** 

We will not work public holidays.

# How the work will affect you

Our work may be noisy at times, but we will do everything we can to minimise its impact, including completing the noisier tasks such as jackhammering and sawcutting by **midnight**.

To minimise disruption to residents, businesses and road users, we will not work more than two nights in any week, or more than six nights in a month.

To ensure we protect public health and safety during the Coronavirus outbreak, we need to change the way we consult with the community. Please be assured we'll continue to respond any questions or concerns you may have about our work.

There will be temporary traffic changes during our work hours to ensure the work zone is safe. Please keep to speed limits and follow signs and traffic controllers' directions.

# Community consultation

In July 2019, Transport for NSW (then Roads and Maritime Services) called for public comment on the proposed measures. In all, 15 submissions were received by individuals and organisations. The most prominent concerns involved potential inconvenience to pedestrians, speed limits, loss of parking and the general effectiveness of the new measures.
