



Upcoming works at King Georges and Canterbury Road, Wiley Park, from Sunday 6 September 2020

The Australian and NSW Governments are upgrading the intersection of King Georges Road and Canterbury Road at Wiley Park to reduce congestion and improve safety.

Intersection upgrade

The intersection of King Georges Road and Canterbury Road currently operates at capacity during peak periods. Queues of vehicles can exceed the existing right turn bays, blocking through traffic.

The project will widen Canterbury Road to provide additional right turn lanes on to King Georges Road in both directions. This will improve traffic flow, reduce congestion and improve safety. Construction is planned to begin in late 2020.



Our Proposed Schedule

Due to high traffic volumes in the area, the majority of construction work for this project will be carried out at night. Our proposed schedule involves working up to five nights a week between **December 2020** and **August 2022**, weather permitting and excluding public holidays.

Our night work hours will be between **8pm and 5am from Sunday to Thursday**. Our day work hours are from **7am to 6pm, Monday to Friday**, and **8am to 1pm on Saturdays.**

Investigation work

We will conduct investigation work on King Georges Road and Canterbury Road intersection, Wiley Park between Sunday 6 September and Sunday 20 September 2020, weather permitting. Our night work hours will be between 9pm and 5am. We will work Monday to Thursday night each week.

How will the work affect you?

Our work will be noisy at times, but we will do everything we can to minimise its impact, including completing the noisier activities by midnight. Some side streets will also be impacted. This work will include testing the existing ground conditions and identifying the location of utilities.

Traffic changes

There will be temporary traffic changes during our work hours to ensure the work zone is safe.

Lane closures will be in place and may affect travel times. Please keep to speed limits and follow signs and traffic controllers' directions.
