Voluntary Management Proposal – Captains Flat Station & Yard **June 2022**

What is a Voluntary Management Proposal?

A Voluntary Management Proposal (VMP) is a legal agreement between the NSW Environment Protection Authority (EPA) and Transport for NSW to plan for and complete remediation. It outlines the key stages in the remediation process and the proposed timing for each stage. If the VMP is not delivered the EPA may issue management orders or take some form of action.

Why has Transport amended the Voluntary Management Proposal?

We have made a Section 44 application to amend the original VMP. The EPA recently approved the amended VMP.

There were some delays in completing the Detailed Site Investigation and we could not meet the original timeframe for the planning stages in the VMP. This was due to the Site Auditor identifying data gaps in the draft report. We needed to complete more investigations and update the report to meet these requirements.

We still plan to complete remediation by December 2023, which is in line with the original timing.

Has the EPA approved the amended Voluntary Management Proposal?

We have been updating the EPA on our planning work and they recently approved the amended
