



M6 Stage 1

Site establishment at Ador Park Precinct and McCarthy Reserve, Rockdale from Monday 17 August



From Monday 17 August, Ador Park Precinct and McCarthy Reserve will close to the public so that we can begin building your new and upgraded community facilities as part of the M6 Stage 1 project.

The fields will stay closed to the public until our upgrade work is completed late next year.

We have engaged Ertech to upgrade the existing facilities at Ador Park and McCarthy Reserve, Rockdale and Brighton Memorial Playing Fields, Brighton-Le-Sands.

You'll notice their team setting up the site and preparing for construction over the coming weeks.

We will continue to keep you informed of our work activities.

What does our work involve?

From Monday 17 August, we will be installing fencing around the site, sampling the soil and scanning the ground to locate underground utilities.

We will use light vehicles, survey tripods, scanning equipment, drilling equipment, an excavator and hand tools to complete this work.

Our work schedule

Our work hours are:

- 7am to 6pm, Monday to Fridays
- 8am to 1pm Saturdays

How will our work affect you?

The fields will be fenced closed until late next year so that work can be carried out safely.

We will need to use an excavator and drilling equipment to carry out our investigations, so there to be some light noise associated with our site investigations.

We will help reduce noise by using low-noise reversing alarms on all machinery and by turning off equipment and vehicles when they are not being used.

Supporting our community

Currently infrastructure construction projects are considered essential to the economy and will continue as planned across the city and the state.

The M6 Stage 1 project will deliver 5,300 jobs and support the local economy.

The safety and wellbeing of our workforce and the wider community is our highest priority. Our people are following hygiene and appropriate social distancing measures and will continue to do so.
