

Intersection improvements on Forest, Bonds and Boundary roads, Peakhurst

Transport for NSW | November 2020

The NSW Government is funding this project as part of the Urban Road Congestion Program to improve safety for road users.

Transport for NSW invited feedback in September and October 2020 on proposed intersection improvements on Forest, Bonds and Boundary roads at Peakhurst, to improve intersection efficiency, safety and reduce the likelihood of the right turning vehicles impeding the movement of the through traffic.

Transport would like to thank everyone who provided feedback.

Engagement outcome

During the engagement period Transport received feedback from 25 community members. Key areas of interest for community members regarding the proposal included:

- support for the proposal and dedicated right turn lanes
- driveway access
- · traffic signal phasing
- · pedestrian safety.

We have summarised all feedback and responses in an engagement report available for viewing at nswroads.work/forestbondsboundaryroad.



The decision

After considering all feedback received, we have decided to proceed with the proposed intersection improvements, which includes:

- installing new dedicated right turn lanes on Boundary Road and Bonds Road approaching Forest Road
- upgrading left turn on Forest Road into Bonds Road to improve visibility
- relocating Bus Stop ID 2210234 on Bonds Road by 10 metres to improve visibility
- removing 2 parking spaces on Boundary Road to allow sufficient lane length for traffic merging into one lane
- adjusting utilities, street lighting, drainage, signage and road marking
- adjusting driveways and footpaths.

In addition to the above, we also listened to the community and will be adding a new pedestrian traffic signal at the north-west corner of Forest and Bonds roads (as shown on map overleaf).

What happens next?

Early works are planned to commence in 2021.

We will continue to keep the community updated as this project progresses.
