## REGIONAL MANAGER'S MESSAGE

I would like to start this week's update with a quote from the South Coast Register editorial of 27 June, which I feel captures much of the community sentiment we have heard since the announcement:

"While the exercise raised anxiety and cost a significant amount of money, at least the homework has been done and some certainty established... This is good news not just for Berry but for the entire Shoalhaven because it means planning can now go to the next stage, which is a complex environmental assessment... there is forward momentum. The decision to go north means the dream of a vastly improved highway is heading closer towards becoming a reality."

Included in this week's web update:

Since December 2011, RMS has had almost 50 meetings with the community. These included five community question and answer sessions, thirteen progress and coordination meetings of the technical information group, thirteen working group meetings, twenty meetings with stakeholders, residents, the Berry Alliance, and the Berry Public School. RMS has also incorporated community suggestions into the design it is taking forward through the environmental assessment process.

Following the Minister's announcement two weeks ago, our project office in Berry has had more than 200 community members stop by and we have had over 2000 hits on the project website.

RMS held a community question and answer session on Tuesday 3 July 2012 at the Berry School of Arts. The bypass review report findings were explained and subject matter experts, the independent reviewer and the project team answered questions from the community. About 200 community members attended.

## **Environmental Assessment Process**

Currently RMS is finalising the Environmental Assessment (EA) for the Department of Planning and Infrastructure. This process is being led by Julian Watson, the RMS Southern Region Project Development Officer. Julian is an experienced environmental planner with a strong background in major infrastructure projects.

In late 2012, the EA will be placed on public display, and formal submissions will be invited. Any submissions received will be referred to RMS and design revisions will be made if relevant and required. Finally, the Minister for Planning and Infrastructure will decide whether to approve the project. To see a more detailed explanation of this process, click here.
