

Travel time savings on Hume Highway in Strathfield

Project Update | September 2018



Completed work at the intersection of Hume Highway and Homebush Road, Strathfield

Roads and Maritime Services has recently completed improvements to the intersection of Hume Highway and Homebush Road in Strathfield, giving you more time for the important things and less time on the road.

Funded under the NSW Government's congestion reducing programs, this project has improved the flow of traffic through the intersection, providing more reliable journey times for and improved safety for all road users.

With approximately 58,000 motorists using the Hume Highway between Centenary Drive and The Boulevarde each day, this corridor is crucial to keeping people moving around Greater Sydney. However, it has a number of 'pinch points' that we are working hard to improve.

Increased traffic numbers were causing the right turn bay from Hume Highway into Homebush Road to overflow and block traffic from moving freely in the neighbouring lanes, creating delays at the intersection.

By extending this existing right turn bay by about 120 metres, more vehicles can now safely

queue to turn right into Homebush Road, helping to keep traffic moving on the Hume Highway towards Ashfield.

We started work on improving the intersection in May. Thanks to good planning and support from the community and motorists, we were able to complete the project on time.

Key benefits

- help keep traffic flowing towards Ashfield
- reduced travel times and provided a more reliable journey for road users
- reduced congestion and improved traffic flow at the intersection by allowing more vehicles to queue in the extended right turn bay
