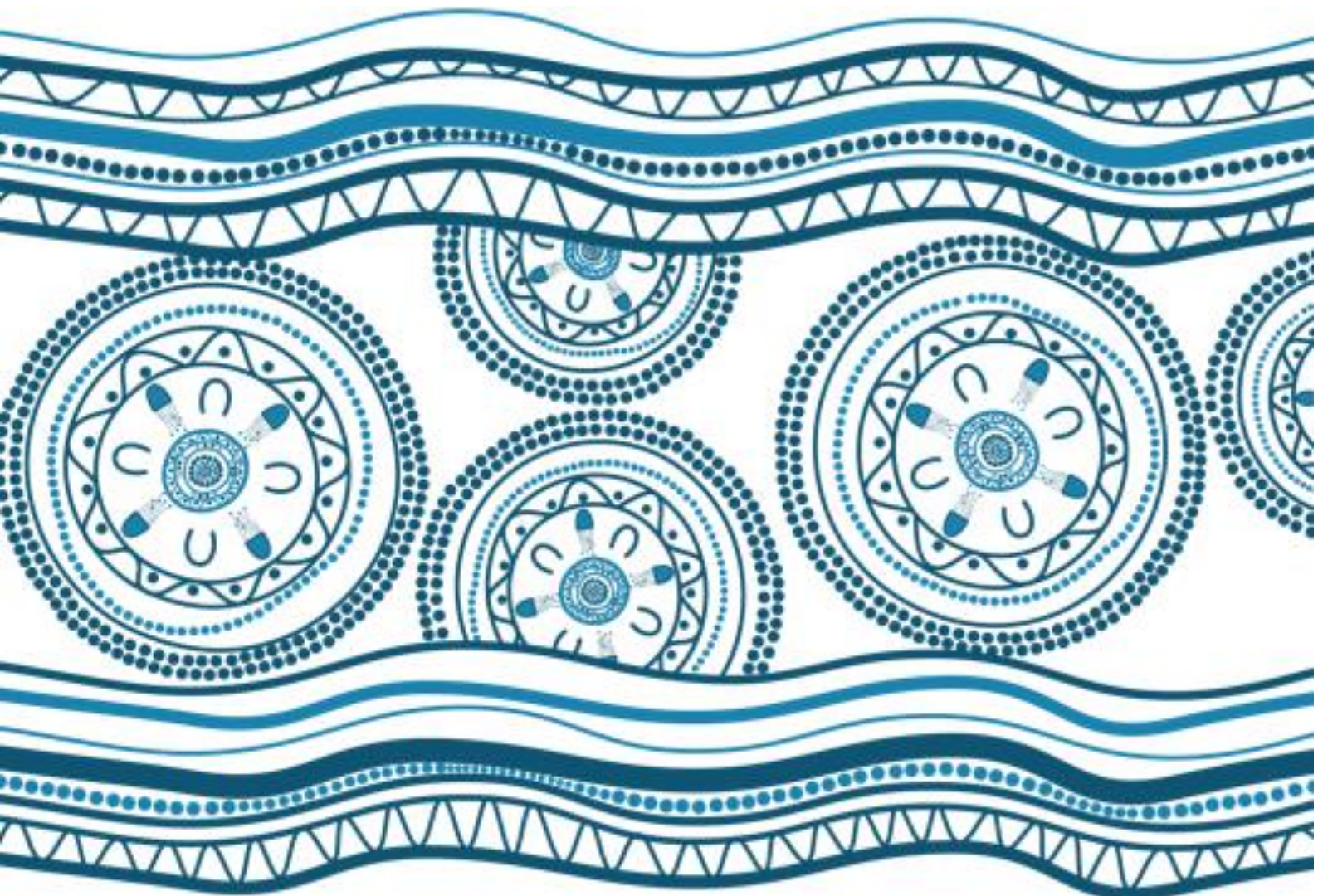

e. an assessment by the person by whom the statement is prepared of the environmental impact of the development, activity or infrastructure to which the statement relates, dealing with the matters referred to in this Schedule, and	Certification page
f. a declaration by the person by whom the statement is prepared to the effect that: <ul style="list-style-type: none"> i. the statement has been prepared in accordance with this Schedule, and ii. the statement contains all available information that is relevant to the environmental assessment of the development, activity or infrastructure to which the statement relates, and iii. that the information contained in the statement is neither false nor misleading. 7 Content of the environmental impact statement

An environmental impact statement must also include each of the following:	
a. a summary of the environmental impact statement,	Executive summary Appendix A (Project synthesis and summary of environmental management measures)
b. a statement of the objectives of the development, activity or infrastructure,	Chapter 3 (Strategic justification and proposal need)
c. an analysis of any feasible alternatives to the carrying out of the development activity or infrastructure, having regard to its objectives, including the consequences of not carrying out the development, activity or infrastructure,	Chapter 4 (Project development and alternatives)
an analysis of the development, activity or infrastructure, and	
i. a full description of the development, activity or infrastructure,	Chapter 5 (Project description)
ii. a general description of the environment likely to be affected by the development activity or infrastructure, together with a detailed description of those aspects of the environment that are likely to be significantly affected, and	Chapters 7 - 25

iii. the likely impact on the environment of the development, activity or infrastructure, and	Chapters 7 - 25
iv. a full description of the measures proposed to mitigate any adverse effects of the development, activity or infrastructure on the environment, and	Chapters 7 – 25 Appendix A (Project synthesis and summary of environmental management measures)
v. a list of any approvals that must be obtained under any other Act or law before the development, activity or infrastructure may lawfully be carried out,	Chapter 2 (Assessment process)
d. a compilation (in a single section of the environmental impact statement) of the measures referred to in item (d)(iv),	Appendix A (Project synthesis and summary of environmental management measures)
e. the reasons justifying the carrying out of the development, activity or infrastructure in the manner proposed, having regard to biophysical, economic and social considerations, including the principles of ecologically sustainable development set out in subclause (4). 1. Subclause (1) is subject to the environmental assessment requirements that relate to the environmental impact statement.	The EIS addresses the SEARs as outlined in Appendix B (Secretary’s environmental assessment requirements and Commonwealth assessment requirements)
2. Subclause (1) does not apply if – a. the Planning Secretary has waived (under clause 2(9)) the need for an application for environmental impact statement in respect of State significant development, and b. the conditions of that waiver specify that the environmental impact statement must instead comply with requirements set out or referred to in those conditions.
