





# Improvements to King Georges Road and Connells Point Road intersection, South Hurstville



King Georges Road and Connells Point Road intersection


Transport for NSW (TfNSW) is making improvements to the intersection of King Georges Road and Connells Point Road (CPR), South Hurstville. Traffic levels have increased causing safety concerns, delays and frustration for motorists and public transport users. TfNSW aim to improve safety and movement of traffic and pedestrians, to ensure we have a transport network that continues to safely meet the needs of a growing population.



### What are we doing

#### Connells Point Road, west of King Georges Road

- Upgrading the existing pedestrian island for improved safety
- Extending the eastbound right turn bay on Connells Point Road by about 34 metres
- Relocate and consolidate bus stops (2221129 and 222195). The new bus stop will require the removal of three parking spaces and be located west of The Mall
- Relocate and consolidate bus stops 2221133 (near Mimosa Street) and 2221153 (adjacent to the BP Service Station). The new bus stop will require the removal of three parking spaces and be located west of The Mall
- Maintaining existing access arrangements.
  Clean up and restoration of your work areas within the site.



### Connells Point Road, east of King Georges Road

- Extending the westbound right turn bay on Connells Point Road by about 57 metres during peak periods, by implementing no stopping in the area on weekdays (Monday – Friday 8am to 10am and 3pm to 7pm)
- No changes to the existing weekend parking
- Minimise impacts to local community.

### Our schedule

Transport for NSW will start work from 17 January 2022 and be completed by mid-2022.

Our night work hours will be between **8pm** and **5am** from **Sunday to Thursday**. Our day work hours are from **7am to 6pm, Monday to Friday**, and **8am to 1pm** on **Saturdays**. We will not be working on public holidays.

### What are we doing?

The works will include:

- setup environmental controls
- surveying
- Setup temporary traffic barriers, signs and fences
- Line marking for extension of right turn
- Reconstruction of pedestrian crossing
- · Removal and relocation of bus stops

## How will this work affect you?

Our work will be noisy at times, but we will do everything we can to minimise its impact, including completing the noisier activities by midnight.
