

NEWCASTLE INNER CITY BYPASS: RANKIN PARK TO JESMOND ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT December 2019

Reporting Period: 1 to 31 December 2019

CONSTRUCTION SUMMARY: The NICB RP2J construction project has been broken into stages:

Stage 1: Detailed design investigation and low impact works

Stage 2: Share Path Bridge

Stage 3: Southern Utilities relocation works

Stage 4: Main RP2J road construction

Pre-construction documentation has been under preparation and review by RMS, ER and DPIE with documentation approved by the ER for commencement of Bridge 7 (SPB). Minor establishment work has commenced. Daracon has been awarded the contract for construction of the Shared Path Bridge (Stage 2) and are scheduled to commence the main SPB work in December 2019.

Low Impact Works

Non-Construction geotech investigation work will continue

Shared Path Bridge

- Site establishment work completed, including Newcastle Road traffic barricade installation and compound site establishment.
- Utility work (water mains, overhead electrical, and protection measures) commenced
- Clearing completed

January 2020 Upcoming Works:

Low Impact Works

Investigation work will continue.

Shared Path Bridge

- Utility relocation work will continue
- Implement traffic changes on Coles Street to allow retaining wall work to commence

Incidents

There was one incident in December.

Construction Water Discharge – 17.12.2019

Whilst undertaking connection of the new water main on Coles Street construction water within the main line was discharged offsite into a stormwater drain. Discharge of water off site ceased immediately and the remaining volume of water was collected and stored within the water cart and relocated to compound area D for discharge within the site boundary. A toolbox talk and review of the EWMS with the project team was undertaken and included discussion on the project requirements in relation to water management and the requirements for water to be discharged off site. Additional corrective actions included; delivery of environmental tool box talks and operational work instructions to the project team, update of the soil and water management plan and revision of the dewatering permit. Incorporation of the RMS golden rules into the site-specific project inductionwas also undertaken.

It is noted that this incident did not trigger the definition of an Incident pertaining that defined under MCoA A37 notification requirements.



CEMP & Minister's Conditions of Approval

■ E27(b) - OOHW for Emergency Works (Burst Water Main) was notified however was not required.

Monitoring

There was no monitoring undertaken in December 2019.

Community Consultation and Complaints
