

NEWCASTLE INNER CITY BYPASS: RANKIN PARK TO JESMOND ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT December 2020

Reporting Period: 1 to 31 December 2020

PROJECT SUMMARY: Delivery of the Newcastle Inner City Bypass (NICB) Rankin Park to Jesmond (RP2J) project has been broken into four stages:

Stage 1: Detailed design investigations and low impact works – in progress

Stage 2: Share Path Bridge - under construction

Stage 3: Southern Utilities relocation works – pre-work planning

Stage 4: Main RP2J road construction – detailed design.

Works underway:

- Stage 1: No work in December
- Stage 2: Daracon is constructing Bridge 7 Shared Path Bridge.
- Stage 3: No work in December
- Stage 4: No work in December

December 2020 Completed Works:

Shared Path Bridge

- Sandstone retaining wall
- Coles Street Earthworks and Pavement works are ongoing
- Stair balustrades installed
- Stair lights installed
- Landscaping on the Southern side
- Concrete footpaths on Southern side were constructed
- Insitu stairs installed
- Newcastle Road bus stop installation
- Type 5 fencing installed along Newcastle Road



January 2021 Upcoming Works:

Shared Path Bridge

- Newcastle Road asphalt and line marking rescheduled from December due to inclement weather
- Landscaping on the northern side
- Coles Street pavement installation
- Coles Street guardrail installation
- Newcastle Road Concrete mow strip (OOHW No.19: 12-14 January 2021)
- Newcastle Road Asphalt Works (OOHW No.18: 22-25 January 2021)

Inspections

- An inspection was held on 3rd December 2020 with the ER, DPIE, TfNSW and Daracon prior to the monthly site meeting

- ERGs are not being held for the Shared Path Bridge or low impact works; however, inspections and project briefing meetings will be undertaken monthly.

There were no Stop Work Notices in December.



Incidents

There was one incident in December.

Wednesday 2nd December 2020 – Mud Tracking

A subcontractor drove a light vehicle into Gate 2 of the Compound Area (Robinson Avenue) on the southern side of Newcastle Road. The vehicle was driven into an area that was saturated from overnight rain resulting in soils sticking to the vehicles tyres. The vehicle then proceeded to drive out of the compound without adequately cleaning the tyres before exiting. As a result, soils were deposited on public roads, including Robinson Avenue and Newcastle Road (west bound). Where possible, site staff immediately removed debris from the impacted roads and the access gate in which the vehicle entered site (Gate 2) was closed. The subcontractor then completed an internal toolbox regarding the incident and the expectations of vehicle entry / exit to the site. In addition, the subcontractor delivered a toolbox talk to entire site personal.

- Commencement of landscaping has had a real positive impact on the outlook of the project works
