

# NEWCASTLE INNER CITY BYPASS: RANKIN PARK TO JESMOND ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT May 2020

Reporting Period: 1 to 31 May 2020

**PROJECT SUMMARY:** The NICB RP2J construction project has been broken into four stages:

Stage 1: Detailed design investigation and low impact works – under construction

Stage 2: Share Path Bridge – under construction

Stage 3: Southern Utilities relocation works – detailed design

Stage 4: Main RP2J road construction – detailed design

### Works underway:

- Stage 1: Low impact investigative drilling works at the Jesmond roundabout. These works have been reviewed
  and approved as low impact works by the ER pursuant to the definition of Construction in the MCoA (i.e.: works
  not defined as construction).
- Stage 2: Daracon is constructing Bridge 7 Shared Path Bridge.

### May 2020 Completed Works:

### Low Impact Works

### Shared Path Bridge

- Southern pile caps poured and backfilled
- Northern pile caps excavated, and reinforcement tied
- Ausgrid works 100% complete
- Concrete retaining walls 60% complete
- Fabrication of main span chord segments fully fabricated and balustrade posts underway
- Main span installation preplanning commenced consultation with emergency services, traffic commander, fabricator, haulage subcontractor, Daracon and TfNSW. Detour routes locked in, including allowance for emergency services. Draft traffic plan developed.

# Shared Path Bridge

- Complete northern pile caps and construct piers on both sides
- Complete concrete retaining wall pours
- Continue fabrication of main span, commence procurement of balustrade panels
- Main span installation preplanning will continue consultation with emergency services, traffic commander, fabricator, haulage subcontractor, Daracon and TfNSW. Detour routes locked in, including allowance for emergency services. Draft traffic plan will continue to be developed.

# **Community Consultation and Complaints**

A single complaint during final Ausgrid nightworks outage. Resident advising WFH ability impacted.

# **Project Positives**

- Community consultation has been ongoing with regards to concrete pours and concrete pump set-ups on Coles Street with over 400 outage affected residents but only 1 minor complaint (as above).
- Retaining wall architectural concrete finish. The formwork has proved a challenge, however a high-quality finish
  is being achieved. This is commendable considering the site constraints (tight working area, dealing with
  overhead powerlines)
