

# NEWCASTLE INNER CITY BYPASS: RANKIN PARK TO JESMOND ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT November 2020

Reporting Period: 1 to 30 November 2020

**PROJECT SUMMARY:** Delivery of the Newcastle Inner City Bypass (NICB) Rankin Park to Jesmond (RP2J) project has been broken into four stages:

Stage 1: Detailed design investigations and low impact works – in progress

Stage 2: Share Path Bridge – under construction

Stage 3: Southern Utilities relocation works – pre-work planning

Stage 4: Main RP2J road construction – detailed design.

### Works underway:

- Stage 1: No work in November
- Stage 2: Daracon is constructing Bridge 7 Shared Path Bridge.
- Stage 3: No work in November
- Stage 4: No work in November

# **November 2020 Completed Works:**

# Shared Path Bridge

- Shared Path Bridge lighting has been installed and commissioned
- CCTV installed
- Main span concrete hobs completed
- Concrete footpaths on Northern side have been constructed
- Decommission and removal of signalised crossing on Newcastle Road
- Newcastle Road pavement excavation and subsoil drainage installation
- Ramp balustrades have been completed
- Final shaping and trimming of southern side in preparation for landscaping
- Blinding for 60m of sandstone retaining wall

- Stair balustrades to be installed

# **Community Consultation and Complaints**

- Complaint from a Coles Street resident regarding damaged vehicle ball joints due to changed access conditions.
  Daracon is currently investigating and will provide assessment shortly.
- Communication is underway with Coles Street residents regarding the impacts from partial road closures for concrete pours and deliveries. To date, discussions have been positive.
- Notifications regarding the upcoming OOHW works have been issued and communications started.
- Letter box drop carried out in Cardiff/Garden Suburb as early consultation for proposed future compound sites.
- Letter box drop related to main works noise testing carried out at community centres, local school, pre-school, church and hospital.

# **Project Positives**

- The Shared Path Bridge was successfully opened to the public on 18 November 2020, allowing for decommissioning of the signalised crossing on Newcastle Road
- Effective ERSED controls and environmental management has resulted in the site performing well during the storm events.
