NEWCASTLE INNER CITY BYPASS: RANKIN PARK TO JESMOND ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT October 2020

Reporting Period: 1 to 31 October 2020

PROJECT SUMMARY: Delivery of the Newcastle Inner City Bypass (NICB) Rankin Park to Jesmond (RP2J) project has been broken into four stages:

- Stage 1: Detailed design investigations and low impact works in progress
- Stage 2: Share Path Bridge under construction
- Stage 3: Southern Utilities relocation works pre-work planning

Stage 4: Main RP2J road construction - detailed design.

Works underway:

- Stage 1: No work in October
- Stage 2: Daracon is constructing Bridge 7 Shared Path Bridge.
- Stage 3: No work in October
- Stage 4: No work in October

October 2020 Completed Works:

Shared Path Bridge

- Installation of main span and concrete deck was poured
- Northern abutment completed and backfilled
- Coles Street stormwater drainage
- Coles Street pavement excavation and placement of SMZ
- Completed remaining concrete pours for elevated ramps and stripped falsework
- Installation of balustrades on both ramps is 75% complete
- Footpath leading to southern elevated ramp poured
- 25 metres of sandstone retaining wall adjacent to the eastbound carriageway completed

November 2020 Upcoming Works:

Shared Path Bridge

- Bridge and ramp street lighting and CCTV camera installation work
- Main span concrete hobs

- Installation of precast stairs
- Installation of new bus stop
- Progress construction of sandstone retaining wall
- Newcastle Road type 5 fence and mowing strip installation

• No monitoring is required for the SPB.

Community Consultation and Complaints

- A complaint was received from a Coles Street resident regarding a water cart idling near property. The water cart driver was instructed to move and drivers were directed not to park on the street and remain within site.
- Communication with Coles Street residents impacted by partial road closures for concrete pours and deliveries going well.
- Upcoming OOHW notifications have been issued. Additional notification for Steel Street daytime closure to be issued shortly as well as December work early notification.

Project Positives

- The main bridge span was installed successfully on the night of 10 October, ahead of schedule. Many local
 residents attended to watch, and the public feedback has been positive.
- Daracon poured the concrete bridge deck utilising an innovative makeshift timber deck they constructed. The timber deck was moveable and allowed them to travel above and across the entire bridge span without contacting the freshly placed concrete. Refer to Images 6 and 7.
- No environmental incidents occurred during October.
