

Princes Highway upgrade

Jervis Bay Road to Sussex Inlet Road upgrade Preferred Strategic Corridor | November 2020



The upgrade will better connect regional centres

Jervis Bay Road to Sussex Inlet Road is a 20 kilometre section of the Princes Highway, crossing a range of local environments, landscapes and connecting multiple communities.

Transport for NSW has identified a preferred strategic corridor following a strategic investigation and design process that assessed four shortlisted options against agreed criteria.

We welcome feedback on the preferred option until **Sunday 20 December 2020**.

The Australian and NSW Governments have announced \$1.5 billion towards upgrading the Princes Highway between Jervis Bay Road and the Victorian border.

An upgrade to the highway between Jervis Bay Road and Sussex Inlet Road is a priority project and part of a 20 year plan to deliver a safe, reliable, efficient and connected transport network.



Key features of the preferred strategic corridor include:

- Connect with the proposed design for the Jervis Bay Road intersection upgrade
- Improved safety and traffic efficiency by planning for an upgraded highway alignment to include two lanes in both directions
- Improved safety, performance and accessibility to key intersections, better connecting communities off the highway
- Improved accessibility in and around Wandandian and Bewong and improve efficiency and reduce congestion on the highway by bypassing east of Wandandian.

Jervis Bay Road intersection upgrade

The Jervis Bay Road intersection has one of the highest volumes of traffic movements between Nowra and the Victorian border. We are currently seeking feedback on a type of grade separation proposed at Jervis Bay Road intersection.


