

Changes to bus stops in Caringbah and Taren Point

Transport for NSW | Community update | July 2021

The NSW Government has funded the Gateway to the South bus improvements program. The program aims to improve the reliability of bus services on southern Sydney's main bus corridors.

Transport for NSW (Transport) invited feedback in February and March 2021 on the proposed bus stop changes in Miranda, Caringbah and Taren Point. The proposed changes would improve bus reliability and on-time running along the Miranda to Bondi Junction via Airport corridor, mainly serviced by bus routes 477 and 478.

What is happening?


Transport have listened to the community and carefully considered the feedback received. We would like to thank everyone who provided feedback.

We have summarised all feedback and responses in an engagement report which we encourage you to view at nswroads.work/suburbanbusroutes3.

Transport intends to proceed with the proposed bus stop changes in Caringbah and Taren Point, but have made some changes to the original proposal to exclude bus stop changes in Miranda as a result of feedback from the local community and discussions with key stakeholders.

Transport will not be progressing with the removal of bus stop ID 2228102 on Kingsway in Miranda. As a result of this decision, the proposed upgrades to the adjacent bus stops ID 2228101 and 2228103 will be omitted from the proposal.

We will continue to work with Sutherland Shire Council and bus operators to progress with the bus stop changes in Caringbah and Taren Point.



- Miranda not proceeding with the removal of bus stop ID 2228102
- Caringbah proceeding with the removal of the southbound bus stop ID 222934, relocating bus stop ID 222933 by 60m south, relocating bus stop ID 222944 by 90m south (refer to map overleaf)
- Taren Point proceeding with the removal of the southbound bus stop ID 222922 near Bay Road, removal of the northbound bus stop ID 222949 at Box Road, relocating bus stop ID 222950 by 90m south (refer to map overleaf)

B2 Caringbah



The bus stop changes on Taren Point Road, Caringbah would include:

- removal of the southbound bus stop ID
 222934 between Captain Cook Drive and Kingsway as there are alternative bus stops within 240m and 140m. Replace with 'No Stopping'
- upgrading adjacent bus stops ID 222933 and 222935 to be DDA compliant
- relocating bus stop ID 222933 by 60m south to provide extra space for bus queue approaching stop. The new relocated bus stop will be upgraded to be DDA compliant.
- relocating bus stop ID 222944 by 90m south to provide extra space for bus queue departing bus stop. The new relocated bus stop will be upgraded to be DDA compliant.



Transport will be upgrading the adjacent bus stops that bus customers will use as a result of the removal/relocation of bus stops. The bus stop upgrades will be carried out to comply with accessibility standards in accordance with the *Disability Discrimination Act (DDA)* 1992.

B3 Taren Point

Taren Point Road near Gwawley Park remove two bus stops and relocate one Taren Point Road Remove bus stop Relocate bus ID 222922 stop ID 222950 by 115m South Bay Rd Box Rd Box Rd Remove bus stop ID 222949 Erskine F Parraweena Rd Parraweena Rd

The bus stop changes on Taren Point Road near Gwawley Park would include:

- removal of the southbound bus stop ID 222922 near Bay Road as there are alternative bus stops within 290m and 210m. Replace with 'No Stopping'
- upgrading adjacent bus stops ID 222921 and 222923 to be DDA compliant
- removal of the northbound bus stop ID 222949 at Box Road as there are alternative bus stops within 280m and 90m. Replace with 'No Stopping'
- upgrading adjacent bus stop ID 222948 near Parraweena Road to be DDA compliant
- relocating bus stop ID 222950 by 90m south closer to Box Road signalised pedestrian crossing. The new relocated bus stop will be upgraded to be DDA compliant.

How will this work affect you?

Our work may be noisy at times in some locations but we will do everything we can to minimise its impact, including completing noisier tasks by midnight.

Driveway and footpath access to properties will be maintained at all times. A temporary relocation of bus stops may be required during works and bus customers will be redirected by site personnel during this time.

During the work, there may be temporary traffic changes during the construction period to ensure the work zone is safe. Any lane closures required will occur outside of peak traffic periods when traffic volumes are lower to minimise disruption to road users. Please keep to the speed limits and follow signs and traffic controllers' directions.



Our work schedule

Transport is planning to implement the bus stop changes later this year. We will keep the community informed before work commence.

Our day work hours will be between 7am to 5pm from Monday to Friday and 8am to 1pm on Saturdays.

If the works need to be carried out at night due to traffic conditions our night work hours will be between 8pm to 5am from Sunday to Friday.

Work will not be carried out on public holidays.
