

# Changes to bus stops on Rocky Point Road in Sans Souci and Ramsgate

Transport for NSW | Community update | November 2021

The NSW Government has funded the Gateway to the South bus improvements program. The program aims to improve the reliability of bus services on southern Sydney's main bus corridors.

Transport for NSW (Transport) invited feedback in February and March 2021 on the proposed bus stop changes on Rocky Point Road in Sans Souci and Ramsgate. The proposed changes would improve bus reliability and on-time running along the Miranda to Bondi Junction via Airport corridor, mainly serviced by bus routes 476 and 477.

### What is happening?


Transport have listened to the community and carefully considered the feedback received. We would like to thank everyone who provided feedback.

We have summarised all feedback and responses in an engagement report which we encourage you to view at nswroads.work/suburbanbusroutes3.

As a result of feedback from the local community, changes have been made to the original proposal.

Transport will not be progressing with the removal of bus stop ID 221924 at the corner of Endeavour Street and Rocky Point Road northbound. As a result of this decision, the proposed upgrades to the adjacent bus stops ID 221923 and 2221925 will not proceed.

We will continue to work with Councils and bus operators to progress with the bus stop changes in Sans Souci and Ramsgate.



- Not proceeding with the removal of bus stop ID 221924 near Endeavour Street
- Sans Souci proceeding with the removal of the northbound bus stop ID 221929 near Newcombe Street and removal of southbound bus stop ID 221978 near Bonanza Parade (refer to map overleaf)
  - Ramsgate proceeding with the removal of the southbound bus stop ID 2217123 near Park Road (refer to map overleaf)

# B2 Sans Souci



The bus stop changes on Rocky Point Road near Newcombe Street and its opposite side would include:

- removal of the northbound bus stop ID
  221929 near Newbombe Street as there are alternative bus stops within 230m and 120m. Replace with 'No Stopping'
- upgrading adjacent bus stops ID 221928 and 221930 to be DSAPT compliant
- removal of the southbound bus stop ID 221978 between Sandringham Street and Bonanza Parade as there are alternative bus stops within 160m and 190m. Replace with 'No Stopping'
- upgrading adjacent bus stops ID 221913 and 221979 to be DSAPT compliant

# B3 Ramsgate



The bus stop changes on Rocky Point Road before Park Road would include:

- removal of the southbound bus stop ID 2217123 before Park Road as there are alternative bus stops within 190m and 240m. Replace with 'No Stopping'
- upgrading adjacent bus stops ID 2217122 and 221977 to be DSAPT compliant



Transport will be upgrading the adjacent bus stops customers will use as a result of bus stop removal. The bus stop upgrades will be carried out to comply with the Disability Standards for Accessible Public Transport (DSAPT)

### Our work schedule

Transport is planning the bus stop changes early next year. We will keep the community informed before works commence.

Our day work hours will be between 7am to 5pm from Monday to Friday and 8am to 1pm on Saturdays.

If the works need to be carried out at night due to traffic conditions our night work hours will be between 8pm and 5am from Sunday to Friday.

Work will not be carried out on public holidays.

# How will this work affect you?

Our work may be noisy at times in some locations but we will do everything we can to minimise its impact, including completing noisier tasks by midnight.

Driveway and footpath access to properties will be maintained at all times. A temporary relocation of bus stops may be required during works and bus customers will be redirected by site personnel during this time.

During the work, there may be temporary traffic changes during the construction period to ensure the work zone is safe. Any lane closures required will occur outside of peak traffic periods when traffic volumes are lower to minimise disruption to road users. Please keep to the speed limits and follow signs and traffic controllers' directions.
