



Proposed safety improvements on Victoria Road between Pennant and Pemberton streets, Parramatta

Project Update

Transport for NSW | July 2022

The Australian and NSW Governments are investing more than \$400 million to improve safety and reduce crashes on NSW roads.

Transport for NSW invited feedback on proposed safety improvements on Victoria Road between Pennant and Pemberton streets, Parramatta between Monday 8 November and Sunday 28 November 2021.

A Have Your Say was widely distributed to residents, businesses and stakeholders in the area. The community notification provided details about the proposed design and how people could have their say.

Stakeholders and community members were encouraged to provide feedback, leave comments and make submissions via email, mail or phone contact. The Have Your Say and

project webpage link was also advertised via the NSW Roads Facebook page and posters were distributed in Collett Street Shops over the consultation period.

What you told us

During the consultation period, Transport for NSW received 37 responses from community members.

Of the 37 submissions, eight responses were supportive or partially supportive of the proposal, 17 responses were against the proposal and 12 did not state a preference,



instead focusing their submission on particular areas of concern or interest.

Key matters raised included:

- support for various aspects of the proposed safety improvements on Victoria Road between Pennant and Pemberton streets, Parramatta
- objection to the proposed restrictions to right turn movements into and out of Pemberton Street including additional travel time required
- objection to the proposed removal of two parking spaces near Collett Village shops
- requests for further information on various aspects of the proposed safety improvements on Victoria Road between Pennant and Pemberton streets, Parramatta.

How we responded

Transport for NSW has carefully considered all feedback received and responded to all submissions in a Community Consultation Report. The report is available to view or download at nswroads.work/victoriaroadsafety

After considering all responses from the Have Your Say community consultation, along with the proposal's safety aims and design requirements, Transport for NSW has decided to proceed with the project.

Transport for NSW would like to thank everyone who took the time to review the design and provide feedback and suggestions.

Next steps

Transport for NSW will finalise the detailed design of the project to proceed to construction.

Construction is expected to commence late in the second half of 2022.

We will continue to communicate with the community and stakeholders prior to start of construction and during construction.
