

Have Your Say – Proposed improvements along Wall Park Avenue, Seven Hills

The NSW Government is proposing parking changes to improve road safety and improve traffic flow.



Roads and Maritime Services is seeking feedback on proposed parking changes along Wall Park Avenue between Blacktown Road and Prospect Highway during peak hours from 6am to 10am and 3pm to 7pm on weekdays in Seven Hills.

We are proposing changes to on-street parking on the northern and southern side on Wall Park Avenue to help ease congestion, especially at the busy intersections of Prospect Highway and Blacktown Road.

The proposal also involves converting the current bus stops into bus zones allowing buses to stop at any time in the bus zones as well as converting the school time parking restrictions to No Stopping during peak times.

Roads and Maritime investigations found in the five years to 30 June 2017, there were 32 reported crashes along Wall Park Avenue between Blacktown Road and Prospect Highway. Our proposal aims to improve safety in this area and reduce congestion and delays.

We have included a map of the existing parking restrictions overleaf.

Key benefits

The proposal will improve:

- Capacity of the intersection and reduce congestion
- Travel times, particularly in peak hours
- Traffic flow at this intersection and approaches
- Safety for pedestrians and road users
- Bus stop access.
