Western Harbour Tunnel and Beaches Link

Temporary works site: Anzac Park, Cammeray

Western Harbour Tunnel and Beaches Link is a major transport infrastructure project that makes it easier, faster and safer to get around Sydney.

As Sydney continues to grow, our transport challenge also increases and congestion impacts our economy.

While the NSW Government actively manages Sydney's daily traffic demands and major new public transport initiatives are underway, it's clear that even more must be done.

Western Harbour Tunnel and Beaches Link will forever change travel between the Northern Beaches, the North Shore and west and south of the Harbour.

It will change the way people move around Sydney.

Thanks to this major project, people will spend less time in traffic and have more time for their families and their daily lives.

Western Harbour Tunnel and Beaches Link includes over 18 kilometres of tunnels (running under Sydney Harbour and Middle Harbour) as well as upgrading over 14 kilometres of surface roads.

These new tunnels will unlock new levels of access to jobs and services including health and education across Sydney.

Most of this project will be deep underground in tunnels and there will be surface connections at Rozelle, Cammeray, Artarmon, Seaforth and Balgowlah.

Some minor works to improve drainage will be required at Anzac Park.

The works will be relatively minor, short-term, and will be on the eastern side of the park, near the Warringah Freeway – away from the War Memorial and Anzac Park Public School.

There will be minimal impacts to the park, and no impact to the school, War Memorial or private property.

The NSW Government has now released the proposed project

reference design and there will be extensive community and stakeholder engagement over the coming months.


We now want to hear what you think about the proposed reference design.

Anzac Park, Cammeray



A temporary site is proposed to support drainage upgrades and local road works.

The works will be relatively minor, short-term and contained on the eastern side of the park, on the opposite side to the War Memorial and Anzac Park Public School.

Kev activities

- New trenches for stormwater drainage through Anzac Park
- Pit for new stormwater drainage under the Warringah Freeway
- Kerb and pavement adjustment work for the realignment of Cammeray Avenue.

Reducing our impact

- Improved drainage in this area, which is currently flood prone
- Park will be fully restored post construction
- No impacts to Anzac Park Public School or War Memorial
- No private property required
- Minimal disruption to park use.
