Windsor Bridge Replacement (SSI-4951): Approval of the nominated Co-Excavation Directors as part of the requirements of condition B3 of Infrastructure approval SSI-4951

I refer to your correspondence dated 16 February 2016, 11 March 2016, 11 April 2016 and 3 May 2016 regarding a request for the Secretary's approval of Dr Matthew Kelly and Ms Anita Yousif to undertake the roles of Excavation Director and Co-Excavation Director respectively, in order to fulfil part of condition B3 of Infrastructure Approval SSI-4951.
