Erskineville Station Upgrade

The Erskineville Station Upgrade is part of the Transport Access Program, a NSW Government initiative to provide a station that is accessible to people with a disability, limited mobility, parents/carers with prams and customers with luggage.

Upcoming work activities

Early investigation works will be undertaken at Erskineville Station to prepare for major construction, which is due to begin in late 2021. This includes identification of underground services and tree trimming. The table below outlines the upcoming work activities at Erskineville Station. Traffic control and signage will be in place to provide directions to cyclists and pedestrians around the work site.

Dates	Work hours	Activities
Tuesday 15 to Friday 18 June	7am to 6pm	We will be working on Platforms 2-3 carrying out underground service investigation works. This involves using a concrete saw to cut the asphalt followed by hand tools to identify the services beneath the station platforms and reinstate. Tree trimming and pruning will also be carried out on Bridge Street to maintain a safe electricity network. A section of the footpath and bicycle lane on Bridge Street, between Ashmore and Swanson Street will also be temporarily closed to allow for work to be carried out safely.
Saturday 26 June	7am to 6pm	On Platform 4, we will be working to undertake tree removal and trimming, subject to approval conditions and Transport for NSW's Biodiversity Offset Program. During this period, Platform 4 will be closed to the general public, and a section of the footpath and bicycle lane on Bridge Street, between Ashmore and Swanson Street will also be temporarily closed to allow for work to be carried out safely.

Plant and equipment

Plant and equipment that will be used include a concrete saw, shovels, wrecking bar, chain saw, elevated working platform, hand and powered tools.
