Projects overview

Transport for NSW is delivering improvements across the state to create vibrant, productive, liveable and sustainable places that support community health, safety and wellbeing. To promote future employment growth, support the local population now and into the future, and to improve connections across Greater Western Sydney, St Marys Station and precinct is being renewed. Transport for NSW projects currently being undertaken in the area include:

- Sydney Metro Western Sydney Airport Enabling Work

Upcoming construction work

St Marys commuter car park extension

We will be undertaking the following construction activities in December 2021 and January 2022:

- fit out and painting work throughout the car park
- continuing structural steel installations for the car park exterior
- concrete pours around the car park perimeter which may require intermittent pedestrian detours
- continuing work on the existing and new lifts
- starting work to reconfigure the layout of the ground floor which will require some parking spaces to be unavailable.

Level 2 of the multi-storey commuter car park is now open. More parking spaces will become available on level 3 in early 2022.

Sydney Metro – Western Sydney Airport Enabling Work



In November, work to finish the relocation and installation of underground power cables through the rail corridor and around the commuter car parks was completed. Some activities including concrete work will continue in the area highlighted yellow on the map above as we complete reinstatement of the footpaths and roads here.

Signage, fencing, temporary pedestrian detours and traffic control will be in place as required to assist pedestrians, motorists, and cyclists around our work areas.

Most of our activities in December and January will be carried out south of the station where we are upgrading the existing access track into the rail corridor (please see the area shown in orange). This work will include excavation, drainage upgrades, pavement construction and some vegetation/tree removal.

We will also be completing geotechnical investigation work around the lift and stairs (indicated in blue) at the entrance to St Marys Station off Queen Street. If new boreholes – allowing access to obtain information from ground materials which will inform future construction – are required, a drill rig will be used to create the boreholes. This is in preparation for the relocation of the existing lift and stairs in 2022.

Access to the station will always be maintained during our work here.

Revised construction hours due to COVID-19

The NSW Government has introduced new rules to support industry and continue the delivery of critical infrastructure during COVID-19.

In accordance with the *Environmental Planning and Assessment (COVID-19 Development – Infrastructure Construction Work Days No.2) Order 2020*, standard construction hours are **7am to 6pm Monday to Sunday, including public holidays**.

Work that is deemed non-intrusive may be completed outside of standard hours and without additional notification. We will notify you in advance of any additional day or night work that may impact you.

There will be a break from construction over the holiday period as follows:

- St Marys commuter car park extension: between Friday 24 December 2021 and Sunday 9
 January 2022.
- Sydney Metro Western Sydney Airport Enabling Work: between **Friday 17 December 2021 and Sunday 9 January 2022**.

Minimising community impacts

We understand that construction activities may cause disruption to the community and every effort will be made to minimise impacts where possible, including:

- turning off equipment when not in use and using non-tonal reversing alarms to reduce potential noise impacts to the surrounding community
- locating equipment as far away from residents and businesses as possible
- directing lighting away from residents
- installing noise barriers to shield residents from high impact noise activities
- conducting on-site monitoring to ensure compliance with strict environmental conditions relating to noise vibration and dust management.
