Projects overview

Upcoming construction work

St Marys Commuter Car Park extension

Construction activities to be undertaken in November include:

- building support work around the car park boundary that may require temporary changes to pathways - access to the station will be maintained
- fit out and painting work throughout the car park
- structural steel installation for the lift shaft and façade
- minor concrete pours near lift lobbies

Please note that in order to undertake the extension work safely, the lift will not be in operation until the end of the year. Subject to approval, up to eight motorcycle parking spaces will be temporarily unavailable until early 2022 to enable the lift work. Parking is currently available on the ground level and Level 1 of the car park.

Sydney Metro – Western Sydney Airport Enabling Work



In November, work on removing, relocating, and installing underground cables will continue through the rail corridor and around the commuter car parks. Activities associated with this work include:

- removal of existing poles and overhead wiring
- installation of new poles
- · cable pulling through the rail alignment
- removal of redundant cables

This work is shown in yellow in the image above. Signage, fencing, temporary pedestrian detours and traffic control will be in place to assist pedestrians, motorists and cyclists around our work areas.

To the south-east of the station, some vegetation removal is required off Glossop Street in preparation for new access tracks into the rail corridor (indicated in orange in the image above).

We will also begin survey and geotechnical investigation work at the existing lift shaft and stairs off Queen Street in preparation for the installation of new structures here in 2022. Please see the area shown in blue above. A drill rig may be required to carry out this work if new boreholes are required. Access to the station will be maintained at all times during the work.

Some out-of-hours work is planned within the station precinct for the commissioning of the new cables from **7pm Friday**, **26 November until 6am Monday**, **29 November 2021**.

Revised construction hours due to COVID-19

The NSW Government has introduced new rules to support industry and continue the delivery of critical infrastructure during COVID-19.

In accordance with the *Environmental Planning and Assessment (COVID-19 Development – Infrastructure Construction Work Days No.2) Order 2020*, standard construction hours are **7am to 6pm Monday to Sunday, including public holidays**.

Work that is deemed non-intrusive may be completed outside of standard hours and without additional notification. We will notify you in advance of any additional day or night work that may impact you.

Minimising community impacts

We understand that construction activities may cause disruption to the community and every effort will be made to minimise impacts where possible, including:

- turning off equipment when not in use and using non-tonal reversing alarms to reduce potential noise impacts to the surrounding community
- locating equipment as far away from residents and businesses as possible
- · directing lighting away from residents
- installing noise barriers to shield residents from high impact noise activities
- conducting on-site monitoring to ensure compliance with strict environmental conditions relating to noise vibration and dust management.
