What's planned?

The Hornsby Commuter Car Park on Jersey Street will feature:

- a new at-grade commuter car park with around 140 parking spaces
- entry and exit of the car park from Jersey Street
- additional accessible parking spaces provided
- dedicated pathways connecting to the existing footpath along Jersey Street
- provision for future electric vehicle charging spaces
- Transport Park&Ride infrastructure (Opal operated boom gates)
- CCTV, lighting and wayfinding signs for improved safety and security
- landscaping within the car park.

Our work schedules

We will be on site from Monday to Friday between 7am and 6pm and between 8am and 1pm on Saturdays. We will contact you to advise of any work required outside of these hours.

What is happening?

We are continuing our work for the new commuter car park in Hornsby. Construction activities will include:

- site inspections and investigation work
- surveying of land and inspection of inground services
- service investigations and disconnections
- site clearance and asphalt removal
- potholing work on Jersey Street
- vegetation clearing and tree removal
- excavation and civil works.

The equipment used during the work will include vacuum trucks, excavators, surveying equipment and hand tools.

How will our work affect you?

Our work may be noisy at times, and we have put measures in place to reduce the impact of this noise, including turning equipment off when not in use and using non-tonal reversing beepers for trucks used on the site.

This work is in line with our COVID Safety Plan in place, including QR codes and masks.

From Thursday 17 February, up to 19 car parking spaces have been temporarily unavailable within the existing Jersey Street car park to allow construction of additional parking to progress.

Tree and vegetation removal

As part of the site establishment and to allow for works to start, some vegetation and trees within the car park site will need to be removed.

The project is committed to removing only the necessary amount of trees. This includes retaining and protecting the two *Eucalyptus salignas* trees 'Blue Gums'.

The trees we are unable to retain will be donated to wildlife parks across Sydney, to be used in various areas in their centres.



We have also reached out to a local elder Uncle Laurie, a traditional owner of Guringai Country, will re-purpose the suitable branches to make Coolamons, an Aboriginal carrying vessel and traditional tools.
