## Riverwood

Transport for NSW is delivering the Riverwood Commuter Car Park, with up to 140 parking spaces to provide you with more convenient access to public transport and to help ease the congestion on our roads.

#### What's planned?

The Riverwood Commuter Car Park on Webb Street will feature:

- A new multi-storey commuter car park with up to 140 parking spaces
- Entry and exit to the car park from Webb Street
- Additional accessible parking spaces
- Provision for future electric vehicle charging spaces
- Transport Park&Ride infrastructure (Opal operated boom gates)
- CCTV, lighting and wayfinding signs for improved safety and security
- Landscaping

#### Site establishment

In June, site establishment work will begin to take place for the new commuter car park in Riverwood.

Construction activities in June will include:

- Site inspections and investigation work
- Surveying of land and inspection of inground services
- Site establishment work
- Service investigations and disconnections
- Geotechnical investigation

The equipment used during the work will include vacuum trucks, excavators, surveying equipment, drill rig and hand tools.

## **Changes to parking**

From Wednesday 1 June, the existing Webb Street car park and approximately 5 on street parking spaces on Webb Street will be permanently removed to allow for construction and operation of the new car park. Please see the map on the following page. Alternative commuter parking is available on Thurlow Street.

#### **Our work Schedule**

We will be on site from Monday to Friday between 7am and 6pm and between 8am and 1pm on Saturdays.

We will contact you to advise of any work required outside of these hours.

## How will our work affect you?



Our work may be noisy at times and we have put measures in place to reduce the impact of this noise, including turning equipment off when not in use and using non-tonal reversing beepers for trucks used on the site.
