Transport for NSW is delivering the Riverwood Commuter Car Park, with up to 140 parking spaces to provide you with more convenient access to public transport and to help ease the congestion on our roads.

What's planned?

The Riverwood Commuter Car Park on Webb Street will feature:

- A new multi-storey commuter car park with up to 140 parking spaces
- Entry and exit to the car park from Webb Street
- Additional accessible parking spaces
- Provision for future electric vehicle charging spaces
- Transport Park&Ride infrastructure (Opal operated boom gates)
- CCTV, lighting and wayfinding signs for improved safety and security
- Landscaping

Site establishment

From July through to September, site establishment work will continue to take place for the new Commuter Car Park in Riverwood.

Construction activities in these months will include:

- Services installation
- Demolition of the existing at grade car park
- Demolition of the existing properties 12-16 Webb Street
- Excavation
- Installation of pile foundation
- Installation of lift pit walls & in ground structures
- Waterproofing and backfill of lift pit
- Installation of stormwater infrastructure.

The equipment used during the work will include vacuum trucks, excavators, surveying equipment, mobile cranes, drill rig and hand tools.

Our work Schedule

We will be on site from Monday to Friday between 7am and 6pm and between 8am and 1pm on Saturdays.

We will contact you to advise of any work required outside of these hours.

How will our work affect you?

Our work may be noisy at times and we have put measures in place to reduce the impact of this noise, including turning equipment off when not in use and using non-tonal reversing beepers for trucks used onsite.
