Additional work areas – February 2022

Project Update

Transport for NSW is delivering approximately 700 additional commuter parking spaces at Schofields to provide the community with more convenient access to public transport and reduce congestion on our roads. The car park is expected to be open to commuters in mid-2022.

Upcoming work

Between Tuesday 22 February 2022 and Thursday 31 March 2022, we will be carrying out work near the Schofields Commuter Car Park work site, to upgrade the Bridge Street car park at Schofields Station and to relocate the pedestrian crossing across Schofields Road, between Railway Terrace and Veron Road.

In the Bridge Street car park at Schofields Station, the upgrade work will involve:	Across Schofields Road, the pedestrian crossing work will involve:
 Closing 19 car parking spaces Delivering and removing plant, equipment, and materials Installing fencing around work area Installing traffic control signage Installing 10 accessible car parking spaces. 	 Delivering and removing plant, equipment, and materials Establishing work area Closing and removing existing pedestrian crossing Installing new pedestrian crossing Kerb and gutter construction activities Traffic control and signage.

These works are in line with the current Public Health Orders and a COVID-Safe plan is in place, including the use of face masks and QR codes.

Our work schedule

Our work hours will be between **7am to 6pm Monday to Friday** and **8am to 1pm Saturday**, weather permitting. If any additional work is required outside of these hours, the community will be notified in advance.



How will the work affect you?

Our work may be noisy at times. We will make every effort to lessen the disturbance where possible including adding shade cloth mesh to fencing, using noise blankets, turning off vehicles and equipment when not in use and using non-tonal reversing beepers. You may notice an increase in construction vehicle movements and dust. Pedestrian detours and partial lane closures will be required. Traffic control and signage will be in place to assist you. Our team will be monitoring these activities and where possible, put additional measures in place.
