

Schofields Commuter Car Park

April 2022

Project update

Transport for NSW is delivering approximately 700 additional commuter parking spaces at Schofields to provide the community with more convenient access to public transport and reduce congestion on our roads. The car park is expected to be open to commuters in mid-2022.

Upcoming work

From 1 April 2022 to 30 April 2022 work at the Schofields Commuter Car Park work site will involve:

- delivering and removing materials using plant and equipment
- adjusting site fencing and amenities
- installing services within the car park
- levelling the site
- asphalt surfacing
- kerb, gutter and footpath construction
- line marking, CCTV, lighting and wayfinding installation
- retaining wall construction
- landscape gardening.

During April work will also continue in areas outside of the Schofields Commuter Car Park work site, including:

- upgrading car park spaces in the Bridge Street car park at Schofields Station
- relocating the pedestrian crossing across Schofields Road, between Railway Terrace and Veron Road.

Landscaping, which may include planting of trees, shrubs and other vegetation will be provided to replace vegetation removed, as part of the project.

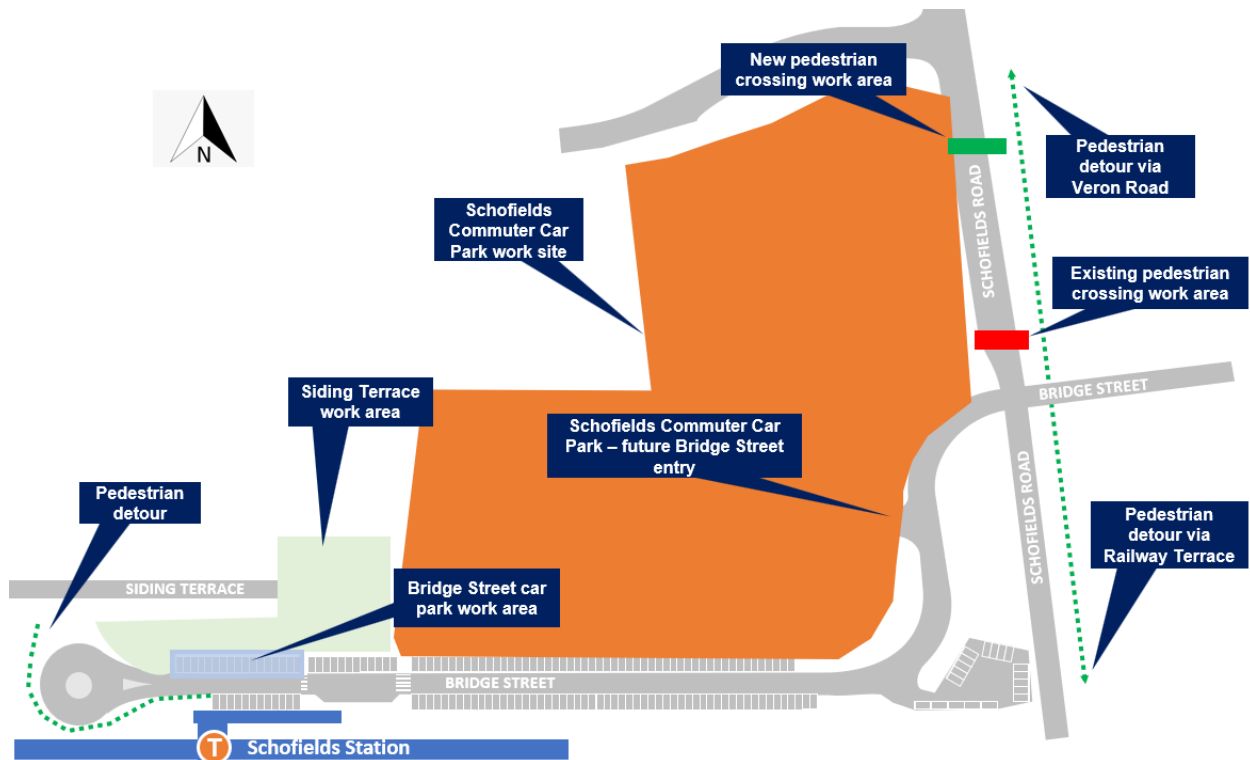
Our work schedule

Our work hours will be between **7am to 6pm Monday to Friday and 7am to 1pm on Saturdays**, weather and site conditions permitting. If any additional work is required outside of these hours, the community will be notified in advance.

How will the work affect you?

There will be some noise associated with this work. Transport for NSW is committed to reducing the effects of construction on the community. We will monitor work activities and put measures in place to lessen the disturbance during the work. You may notice more construction vehicles and dust. We will also be monitoring these activities and where possible, put dust control measures in place. Pedestrian detours, signage and traffic controllers will be in place. For your safety, please follow the signs and the directions of traffic controllers.
