

# St Marys temporary bus interchange

## Update on road works March 2022

Works are continuing by Transport for NSW to build a temporary bus interchange within the former Veness Place car park on Station Street to enable construction of the Sydney Metro – Western Sydney Airport. The temporary bus interchange will be in use for buses and bus passengers from **9pm Monday 7 March 2022**, with final remaining work to be completed by April 2022.

## Using the temporary bus interchange

From 28 February, signage will be in place at the existing bus interchange to inform bus passengers of bus stop relocations which will be in effect from **9pm Monday 7 March 2022**.

The table below outlines the new bus stop locations for each bus route.

Relocated bus stop	Bus Route
Stand A	Routes 835 & N70
Stand B	Routes 770, 771, 775, 776, 779 & 781
Stand C	Routes 745, 758, 759, 774, 782, 835 & S11

## Traffic and access changes

Access to Station Street from Queen Street will be for buses and taxis only from **9pm Monday 7 March 2022**. Variable Message Signs (VMS) will be in place on Queen Street and Station Street to ensure drivers are aware of this change and mapping services will also be updated. Vehicles will be required to turn left into Nariel Street or access the eastern end of Station Street via Phillip and Lethbridge Streets. Existing residential access from the eastern end of Station Street is unchanged. These traffic changes are shown on the map below.

## What happens next?

We will continue general construction, road, and drainage work on Station Street and in the area surrounding the temporary bus interchange (see map below). Various works will also be carried out at night to minimise traffic disruption.

### 1 Temporary work site set up

We will be setting up a temporary work site at the entrance of the existing bus interchange while we complete our remaining work. This work involves completion of stormwater works, CCTV installation, disconnection of utilities at the existing bus interchange and installing new asphalt.

Once we have completed our work, we will remove and rehabilitate the temporary work site.

### 2 Station Street truck and equipment holding bay

We will be delivering equipment and materials to the laydown area located at 1a Station Street, adjacent to the existing bus interchange.

### 3 Station Street pavement and asphalt works

We will be carrying out pavement and asphalt work along Station Street at night. This work involves resurfacing the existing road.

Traffic controls will be in place to prevent residents parking when work is taking place. We kindly ask residents and visitors to assist us in making sure **no cars are parked on the southern side of Station Street between 6pm and 6am Sunday to Thursday nights**. We thank you for your patience and understanding.

#### 4 Station Street concrete barrier installation

We will be installing concrete barriers on Station Street to close off access to the western side of Station Street and the temporary bus interchange.

#### 5 Phillip Street, Queen Street and Station Street works

We will be installing new line marking along Phillip Street, Queen Street (between Station and Phillip Street), and on the western side of Station Street (including within the temporary bus interchange). This work will be carried out at night and traffic control will be in place during when work is taking place.

We will also be installing new streetlights on Queen Street (between Nariel Street and Station Street).

### What to expect

Equipment used for this work includes but is not limited to: vacuum excavation trucks, road-saws, jack hammers, excavators, rigid trucks, concrete trucks, rollers, water trucks, asphalt pavers and mobile cranes.

There will be temporary traffic changes during our work hours to ensure the work zone is safe. This may affect travel times. Please keep to speed limits and follow signs and traffic controllers' directions.

There will be minor traffic disruptions and an increase in light and construction vehicles throughout the period of works with traffic control measures in place. Access to driveways and buildings will be maintained but may be interrupted during night works. Utility services will be maintained and garbage collections and deliveries will be possible.

To minimise noise and dust impacts we have put in place the following measures:

- a work schedule that provides respite of 2 consecutive weekend nights – Fridays and Saturdays – without any night works
- stopping noisier work, such as saw-cutting concrete or using hammer plates on road surfaces, at night by 10pm and using noise curtains, where feasible, for mobile or temporary works.

### Our work schedule

Our standard work hours will be **Monday to Sunday from 7am to 6pm**. On weekends, high noise activities will only take place on **Saturdays between 8am-1pm**.

Our night work hours will be **Sunday to Thursday nights from 8pm to 5am**. Night works will not take place on Friday or Saturday nights.

These works will be undertaken in accordance with Public Health Orders and a COVIDSafe plan is in place. Please note that weather and site conditions may impact our planned dates of work and require some scheduling flexibility or additional days' work. We will continue to keep the community informed of construction plans. The project is on track for completion in April 2022.
