# Have your say on Burley Griffin Way at Binalong safety improvements

# **Community update**

December 2023



The NSW Government is upgrading the Burley Griffin Way intersection with Fitzroy Street at Binalong.

#### What are we doing

Transport for NSW is proposing safety improvements at the intersection of Burley Griffin Way (Stephens Street) and Fitzroy Street at Binalong to reduce the risk and severity of crashes. We are sharing the proposed design with the community for feedback to assist us in the final design.

#### Proposed design

The proposed design can be viewed over the page and includes:

- road widening at the intersection of Fitzroy and Stephens streets
- relocating the overhead electrical services to accommodate the intersection upgrade
- building a concrete median on Fitzroy Street for safer vehicle movements
- installing 250 metres of safety barriers
- closing access to and from Richmond Street
- removing access to Fitzroy Street for heavy vehicles over 15 tonnes
- upgrading signage including gateway treatments.

#### Community feedback

We heard the community's concern with safety at this intersection and are committed to working with Yass Valley Council and the community to provide a safer intersection.



## Closing access to Richmond Street

Transport is proposing to close access to Richmond Street from Stephens Street to accommodate the installation of safety barriers that will protect power poles and private property from run-off-road type crashes.

Closing this access to Richmond Street would improve safety in the area by removing the opportunity for dangerous movements out of the intersection. Moving all vehicles to the Fitzroy Street intersection following its safety upgrades will improve safety for motorists accessing Stephens Street.

#### Next steps

Following the feedback period, Transport will review all feedback received and use this information to complete the final design.

We will share the final design with the community in coming months and anticipate work to start in mid-2024.
