


Kamay Ferry Wharves

Extended work hours on Saturdays at La Perouse and Kurnell

November 2023





Transport for NSW acknowledges the Gweagal and Bidjigal people as the Traditional Custodians of the lands on which we work and pays respect to Elders past and present.

The NSW Government is replacing the previous ferry wharves at La Perouse and Kurnell as part of the Kamay Botany Bay National Park, Kurnell Master Plan.

From **Saturday 11 November**, for a period of approximately **eight months**, we will work extended hours on Saturdays, finishing our work **at 6pm** (previously we finished at 1pm).

While we are extending work hours, we will ensure that the noisiest piling work continues to stop at 1pm on Saturdays.

Why are we extending our work hours?

We are committed to building the Kamay Ferry Wharves safely and as efficiently as possible to limit impacts to the community.

Our contract partner, McConnell Dowell, is extending Saturday work hours at La Perouse and Kurnell sites so that we can maximise our workers' time and equipment. This will allow us to complete some of our work activities faster and minimise overall disruption to the community.

As per our project conditions, we carried out targeted consultation with nearby residents and businesses to seek agreement for the extended work hours.

The results were:

- 94% of respondents agreed at Kurnell
- 92% of respondents agreed at La Perouse

The independent Environmental Representative has assessed the responses and approved the work hours application. Extended work hours can be reviewed by the Environmental Representative at any time.

Our work hours from 11 November

- On Saturdays we will work from 8am to 6pm.
- We will not work these extended Saturday hours over the holiday period between 16 December 2023 and 6 January 2024 inclusive.
- Our weekday hours have not changed. We will continue to work 7am to 6pm, Monday to Friday.

What will this mean for you?

We will carry out our typical work activities except for the noisier impact piling which will continue to stop at 1pm. This includes:

- moving barges and crane barges
- moving and storing piles and other equipment
- welding and concrete installation activities
- installing the wharf support beam sections
- operating the temporary jetty at Kurnell
- carrying out bored/drilled piling (this is the quieter piling method).

In general, we anticipate the noise level would remain the same as current weekday levels (without impact piling) or be reduced.

Managing our impacts

- There will be no additional vehicle or truck movements during the extended work hours.
- Workers will park inside the construction site.
- We'll conduct noise verification monitoring.
