

# Community Notification

## Stanmore Station Upgrade

May 2023



Transport for NSW acknowledges the Gadigal and Wangal people of the Eora Nation as the Traditional Custodians of the lands on which we work and pay respects to Elders past and present.

The Stanmore Station Upgrade is delivered as part of the Transport Access Program

The upgrade will provide a station precinct that is accessible to people with a disability, limited mobility, parents/carers with prams and customers with luggage.

### What work are we doing?

Work includes:

- Installation of the lift cars, as well as glazing and concreting the lift shafts
- Converting approximately eight car spaces on Douglas Street into two new accessible car spaces, and one kiss and ride space. This includes removal of two small trees
- Re-grading the existing shared path on Douglas Street to be DDA compliant
- Construction of a brick retaining wall on Trafalgar Street
- Installation of services on all platforms
- Ongoing upgrades to the family accessible toilet. This facility is temporarily unavailable.

### When and where we'll be working

We will be working at the station and the site compound at 71 Railway Avenue.

Standard working hours are **7am to 6pm, Monday to Friday**, and **7am to 1pm, Saturday**.

Some activities are required to be undertaken outside of our standard work hours.

### Out of hours work

Some activities are required to be undertaken outside of our standard work hours.

We will be working on **Monday 8 May** and **Tuesday 9 May** from **7pm to 5am** to install the lift shaft on platform 3.

### What will this mean for you?

- A crane will be set up on Trafalgar Street to facilitate the installation of the lift shaft
- Trafalgar Street will be temporarily closed between Merton Road and Harrow Road. Detours will be in place. See map overleaf
- Driveway access for residents within the closure zone will be maintained at all times
- Intermittent shared path closures on Douglas Street during regrading works
- There may be intermittent periods of high noise from machinery and equipment
- Increased truck movements, traffic controllers and signage for lane and road closures

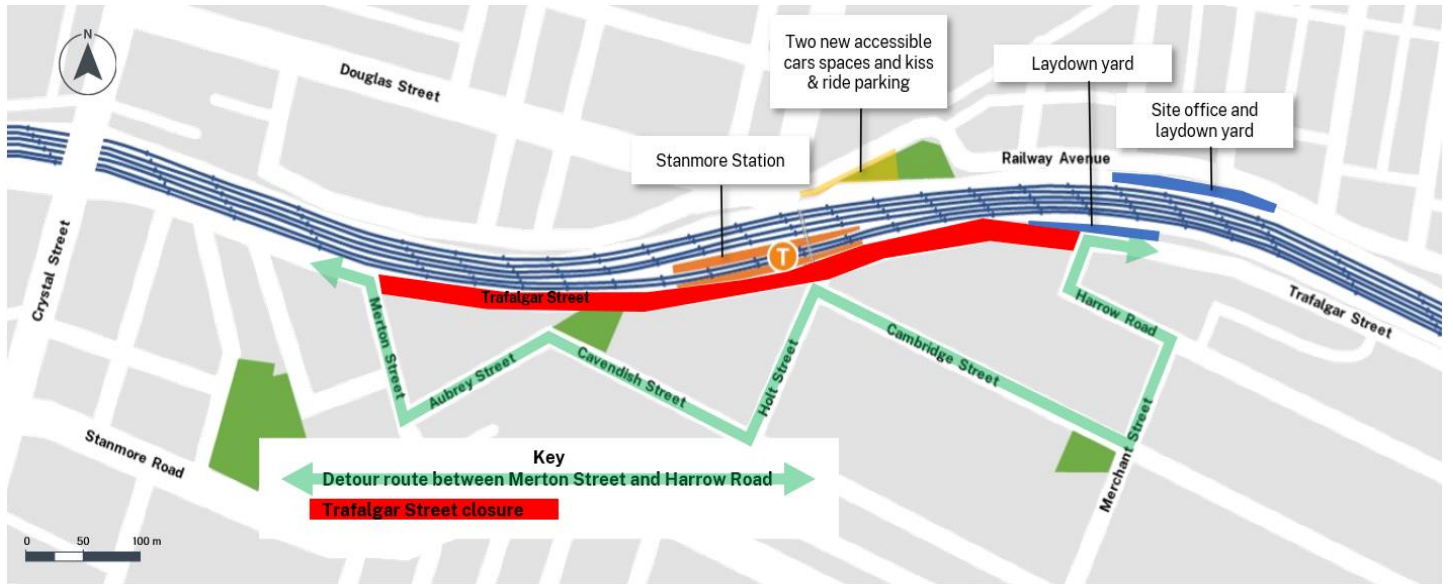
### Managing our impacts

reducing noise wherever possible and directing lighting away from residential properties wherever possible.
