

Sydney West Overhead Wiring Upgrade Toongabbie, Pendle Hill, Wentworthville and Westmead

More Trains, More Services

March to May 2023

Transport for NSW pays respect to Elders past and present, and recognises and celebrates the diversity of Aboriginal peoples and their ongoing cultures and connections to the lands and waters of NSW.

The More Trains, More Services program will simplify and modernise the rail network creating high capacity, turn up and go services for many customers. It means customers can expect more frequent train services, with less wait times, less crowding on a simpler and more reliable network.

This project will upgrade the overhead wiring infrastructure inside the rail corridor to improve train movements through Toongabbie, Pendle Hill, Wentworthville and Westmead stations. To achieve this, the project scope includes installation of new overhead wiring and modifications to existing overhead wires.

What work are we doing?

A contract has been awarded to Next Rail, a partnership between John Holland, Jacobs and Transport for NSW, to start investigation work for the Sydney West Overhead Wiring Upgrade project.

Investigation work will be carried out from March to May 2023 to assist with early planning and design. This will involve site surveying, locating existing underground services and understanding ground conditions inside the rail corridor.

Main construction is scheduled to start in mid-2023 and we will keep you updated as our work progresses.

When and where we'll be working

From March to May 2023, work will take place inside the rail corridor as shown on the map overleaf.

Standard construction hours are between **7am and 6pm Monday to Friday and 8am and 1pm on Saturdays.**

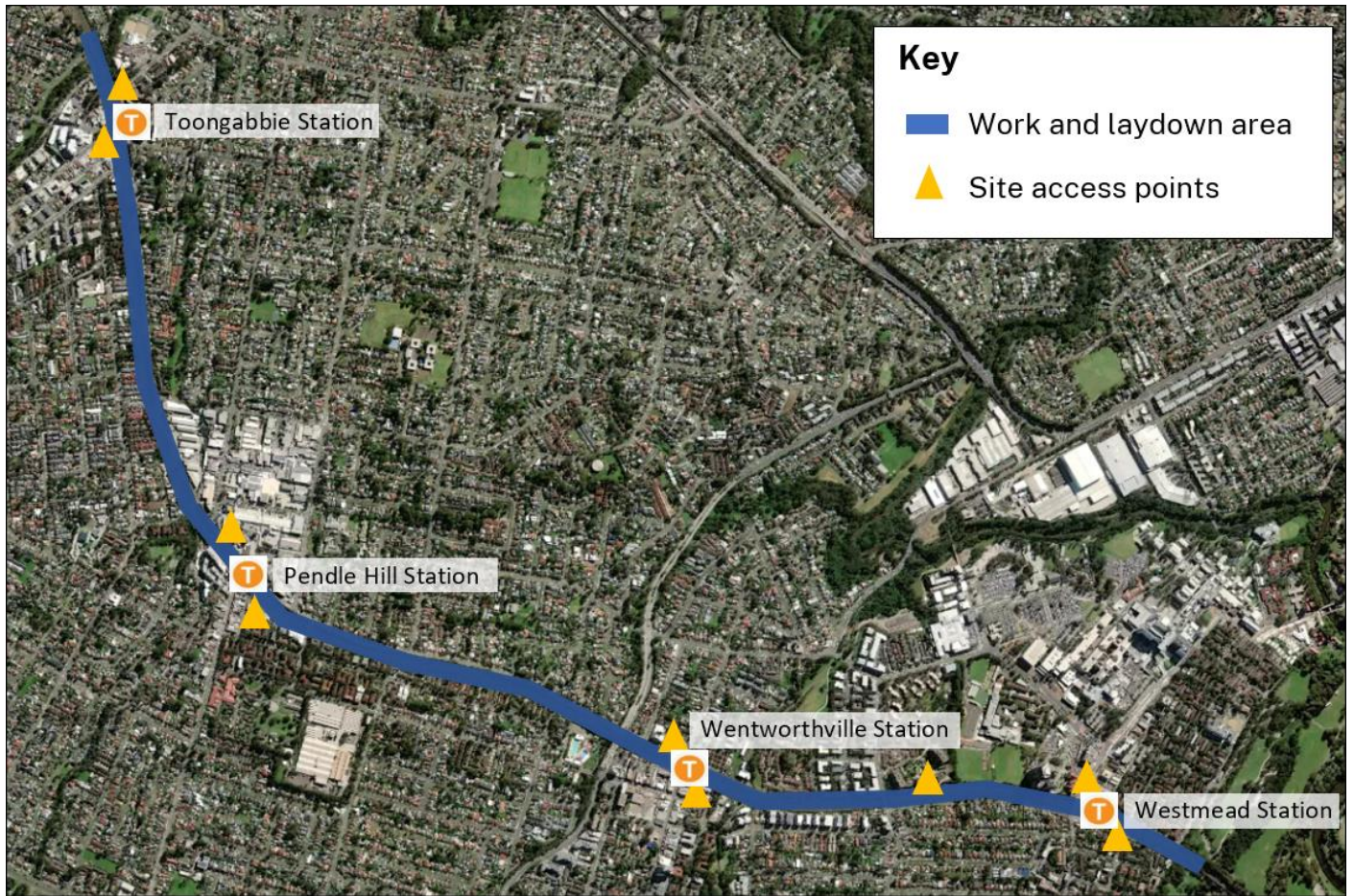
Some work will take place outside of these hours from **6am to 6pm on Saturday 1 April and Sunday 2 April 2023.** This work will take place during a scheduled Sydney Trains trackwork period when no trains will be running. Scheduling work outside of standard construction hours enables our team to complete essential activities safely.

What will this mean for you?

You may notice:

- Workers and vehicles
- Noise from machinery and equipment
- Temporary parking restrictions
Signage will be installed to indicate when and where the temporary parking restrictions will be in effect.
