Wolli Creek Power Supply Upgrade Project

What are we doing?

Transport for NSW is building a new substation within the rail corridor to create the necessary power supply to support the increase in the number of trains travelling along the T8 Airport Line in the future.

We have recently completed the extension of the platform canopy at Wolli Creek Station to increase weather protection and encourage customers to use the full length of the platform, reducing crowding at busy times.

What's been happening?

During March, we carried out the following activities:

- Continued building the new substation including cabling, electrical, and structural installations.

What's planned next?

In April, we will carry out the following activities:

- Continuing building the new substation including cabling, electrical, and structural installations
- Cable installations on Spark Lane
- Signalling installations.

When will work take place?

The standard construction hours for the Wolli Creek Power Supply Upgrade Project are:

- 7am to 6pm, Monday to Friday; and
- 8am to 1pm, Saturdays.

We will notify you in advance of any out of hours work.

Upcoming out of hours work

The signalling installation work will be completed outside of standard construction hours as part of a scheduled Sydney Trains trackwork period when no trains will be running:

- Between **1am, Saturday 30 April through to 2am, Monday 2 May.**

Scheduling construction work outside of standard construction hours enables our team to complete essential activities safely.

Rescheduled work on Spark Lane

The cable installations on Spark Lane will occur:

- Between **7am and 6pm, Saturday 30 April and Sunday 1 May.**

Traffic control will be onsite to enable the safety use of Spark Lane for residents.

Where will work take place?

The above map shows the work area inside the main site compound of 5A Lusty Street, Wollongong Creek.

The project team will continue to utilise the site compounds for deliveries, storage of materials and equipment, offices, pre-start work meetings and worker parking.

The project team understands construction activities may cause disruption for the community. We will seek to minimise impacts as much as possible and adhere to strict environmental conditions relating to noise, vibration and dust management.
