Wolli Creek Power Supply Upgrade Project

What are we doing?

Transport for NSW is building a new substation within the rail corridor to create the necessary power supply to support the increase in the number of trains travelling along the T8 Airport Line in the future.

What's been happening?

During April, we carried out the following activities:

- Continued building the new substation including cabling, electrical, and structural installations
- Planning for the cable installations on Spark Lane which will happen **this Saturday 30 April and Sunday 1 May** between **7am and 6pm**.
- Planning for the signalling installation planned to happen between **1am, Saturday 30 April through to 2am, Monday 2 May**.

What's planned next?

In May, we will carry out the following activities:

- Continuing building the new substation including cabling, electrical, and structural installations
- Cable installations on Spark Lane
- Signalling installations
- Track installations
- Drainage work
- Overhead wiring work.

When will work take place?

The standard construction hours for the Wolli Creek Power Supply Upgrade Project are:

- 7am to 6pm, Monday to Friday; and
- 8am to 1pm, Saturdays.

We will notify you in advance of any out of hours work.

Reminder Out of Hours work this weekend 30 April – 1 May

Further to our April notification, please note the cable installations on Spark Lane will happen **this Saturday 30 April and Sunday 1 May** between **7am and 6pm**.

Traffic control will be onsite to enable the safety use of Spark Lane for residents.

Signalling installation will happen between **1am, Saturday 30 April through to 2am, Monday 2 May**.

Upcoming out of hours work

The delivery of the power transformers for the substation has been rescheduled to between **2am to 7am, Thursday 5 May and Friday 6 May**.

The deliveries must occur outside of standard construction hours due to road and safety regulations.

To minimise noise impacts for our neighbours, the project team has scheduled the crane removal of these transformers from flatbed trucks to a designated area in the 5A Lusty Street site compound during this time, with all other work to occur after 7am.

Some construction work is planned to take place outside of standard construction hours inside the Wolli Creek rail corridor:

- **between 6am and 6pm, Saturday 21 May and Sunday 22 May.**

This work will take place during a scheduled Sydney Trains trackwork period when no trains will be running. Scheduling work during Sydney Trains trackwork periods enables our team to complete essential activities safely inside the rail corridor.



Where will work take place?

The above map shows the work area inside the main site compound of 5A Lusty Street, Wollri Creek.

The project team will continue to utilise the site compounds for deliveries, storage of materials and equipment, offices, pre-start work meetings and worker parking.

How do we consider the community?

The project team understands construction activities may cause disruption for the community. We will seek to minimise impacts as much as possible and adhere to strict environmental conditions relating to noise, vibration and dust management.

How are we staying safe?

We continue to deliver projects across NSW while ensuring the safety of all staff and the community. All work will be carry out in line with current Australian Government guidelines around slowing the spread of COVID-19.
