Tweed Heads Boat Maintenance Facility

The NSW Government is delivering major improvements to maritime infrastructure and facilities to help the boating and wider community safely access, use and navigate our rivers and coastal waters.

Background

The Tweed River is used by recreational boaters, commercial fishing vessels and Maritime related tourism operators. The old slipway had been in operation since the 1960s and needed replacement to meet new operational and environmental standards.

The new Tweed Heads Boat Maintenance Facility was delivered as part of the maritime infrastructure plan.

Work on the project started in 2021 and we are delighted to inform you that the project has been completed, and the facility is now available to use by the community.

Commercial fishing vessels, tourism operators and local boaters now have the use of the latest in modern boating infrastructure on the Tweed River.
