



NEWCASTLE INNER CITY BYPASS: RANKIN PARK TO JESMOND (SSI-6888) ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT January 2024

Reporting Period: 22 December 2023 to 31 January 2024. This reporting period is for the end of December and January construction works. The site was shutdown from the 21 December 2023 for the holiday period and was reopened on 8 January 2024. This January 2024 ER report accounts for the shutdown period.

This Environmental Representative (ER) Monthly Report is prepared in accordance with the Minister's Condition of Approval A26(k) for the Newcastle Inner City Bypass: Rankin Park to Jesmond (SSI-6888) and is consistent with the Environmental Representative Protocol (October 2018).

PROJECT SUMMARY

Delivery of a 3.4km section of the Newcastle Inner City Bypass (NICB) which will be built between Rankin Park to Jesmond (RP2J) and to the west of the John Hunter Hospital.

The Rankin Park to Jesmond project is the fifth section of the NICB, which forms part of the Transport for NSW long term strategy to connect the Pacific Highway between Bennetts Green and Sandgate.

The project has been broken into four stages:

- Stage 1: Detailed design investigations (geotechnical and utility investigations) and low impact works (house demolition, heritage investigations, at-house noise treatment works, access, installation of environmental controls).
- Stage 2: Shared Path Bridge.
- Stage 3: Southern Interchange Utilities relocation works.
- Stage 4: Main RP2J road construction.

PROJECT WORKS SUMMARY

- Stage 1: Low Impact Works including, House Demolition which was completed June 2021.
- Stage 2: Shared Path Bridge was completed March 2021.
- Stage 3: Southern Interchange Utility Relocation works were completed in August 2022.
- Stage 4: Main construction works underway, commenced March 2023. At House Noise Treatment (AHNT) consultation and implementation commenced March 2022.

January 2024 Completed Works

Non-compliances

There was one non-compliance in January.

Monday 15 January 2024 – Truck and Dog Parking

Trucks were scheduled to be inducted prior to starting haulage activities on the project. The sub-contractor was provided a Vehicle Movement Plan (VMP) showing the approved heavy vehicles routes and parking locations for the project. At 6.30am, five empty truck and dogs have entered Victory Parade and parked on the shoulder of the local road prior to being inducted on the project. Truck drivers were attending site inductions at the Jesmond compound and were immediately instructed by Fulton Hogan to remove vehicles from the area. Trucks had vacated the local road by 7.15am and entered the project site.

Environmental Issues (i.e.: not classified as Incidents as per MCoA)

There was one environmental issue in January.

Monday 29 January – Asbestos Containing Materials (ACM)

During foundation excavation in zone 1 on 29 January 2024, Fulton Hogan identified broken pipe on the western side of the entry/exit gate. Works were ceased and a 5 m area was flagged off. Hazmat was then contacted and attended site to take a sample and make an assessment of the substance.

<u>Monitoring</u>

- Monthly noise monitoring as per NVMP did not exceed NML's.
- Water quality monitoring was undertaken pursuant to the SGWCMP during the month. The laboratory results were not available at the time of reporting.
- Dust gauges were changed on 2 January, the rolling averages are all below the criteria of 4, noting that there is not sufficient data for the rolling average to be reported accurately.



Complaints

- 2 x night noise southern interchange (same stakeholder)
 - Noise monitoring completed.
 - White noise machine provided to stakeholder no further complaints.
- 1 x workers parking on Myall Street non site vehicle cars attending induction not realising they could park on site – more specific instructions added to induction invite.
- 1 x trucks parking on Victory Parade/Myall Street superintendent spoke to drivers, misunderstanding about entry to site.
- 1 x dust pool floor stained dust monitor has no exceedance undertook real time dust monitoring – near Newcastle Road.
- 1 x damaged tyre.
- 1 x light spill lights tilted McCaffrey Drive.

Trends

- Low impact controlled blasting questions and meetings.
- Shared user path current detours and future design.

Summary of Issues and Events

- Umwelt archaeologists handed over the artefacts located at 'Hollywood' to Newcastle Museum.
- Yallarwah Circle of reflection working bee weeding and planting shrubs/trees that Fulton Hogan and JHH purchased from Trees of Newcastle that had been germinated and grown from the seed collection off the RP2J site.


- Yallarwah Circle of Reflection re-opening 20 February.

Closing Remarks

The construction works for the period to end of January consisted primarily of site shutdown works in late December, then January included site reopening works, earthworks, creek diversions, Dark Creek culvert works, traffic diversions, pilling and pouring bridge footings, installation of permanent drainage and landscaping, shotcreting batters and progressive ErSed control design and installation and residential property noise treatment works are also ongoing.

Currently, the key environmental risks include dust, surface water management, working in waterways (Dark Creek), traffic control and diversions, and managing and communicating OOHWs with stakeholders. The monthly inspection was carried out during dry weather conditions after the construction team was fully operational. A number of minor environmental matters were raised and provided in a report to the site environmental team. A single non-conformance occurred on the site





The environment project team are managing the site's environmental risks appropriately with ongoing inspections and remediation occurring when required. Environmental issues for the month included minor ErSed control repairs and updating approvals.
