

Captains Flat Remediation Options Assessment

In 2022, Transport completed a Remediation Options Assessment (ROA) of the rail corridor to identify the preferred remediation methodology and criteria for the Captains Flat Rail Corridor.

The outcomes and approved remediation methodology were:

- to remediate the Site to public open space criteria
- to return the Site to the Captains Flat Pathway to Gold Heritage Trail (Heritage Trail)
- to dispose of the waste material in the Lake George (legacy) Mine Containment Cell.

Captains Flat Remediation Options Assessment

- In December 2023, Transport completed a Future Land Use Assessment for the former Station Master's Cottage.
- Transport reviewed the community feedback and after careful consideration, a decision has been made to proceed with the demolition of the former Station Masters Cottage.
- The outcome and approved future land use is to demolish the buildings and to remediate the Site with the rail corridor and for the vacant land to form part of the Heritage Trail.
- A final ROA is no longer needed to progress the remediation of the cottage.

Captains Flat Remediation Action Plan

- In November 2022, a Remediation Action Plan (RAP) was completed for the rail corridor.
- The RAP identified a number of data gaps which require a Supplementary Site Investigation (SSI).
- The RAP for the rail corridor will be updated to include the former Station Master's Cottage. It will also incorporate the findings from the Supplementary Site Investigation.
- The SSI and Interim Audit Advice (IAA) will be completed by February 2025.

Captains Flat Former Station Master's Cottage - Voluntary Management Proposal

- We have completed all milestones in Stage 1 of the Voluntary Management Plan (Future Land Use) for the former Station Master's Cottage.
- We have prepared Phase 2 of the VMP (Remediation Planning).

Captains Flat Rail Corridor - Voluntary Management Proposal

- Due to extensive delays in procurement for the current works, we are behind in schedule resulting in us not being able to meet the current VMP milestones.
- We have prepared and submitted an application to amend the current VMP (Phase 1 Remediation Planning) and awaiting approval by the EPA.
- As procurement for this Stage is now complete, we are confident of meeting these milestones.

Captains Flat Rail Corridor - Voluntary Management Proposal

- The contamination remediation process is regulated and complex.
- We are following industry best practice and engaging industry leading professionals to obtain the best possible outcomes for the site. As such, these matters can take some time to resolve.

- Investigations for this site will commence in 2024 and will include a:
 - Detailed Site Investigation
 - Interim Environmental Management Plan
 - Health and Ecological Risk Assessment
- Investigations to be completed in 2025.



Former Station Master's Cottage -Heritage interpretation

Next steps for the Former Station Master's Cottage

- Transport will consult Council and the community later in the year on Heritage interpretation for the vacant former Station Master's Cottage (FSMC) site.
- Consultation timelines are yet to be confirmed.
- Consultation on Heritage interpretation will run concurrently to the remediation planning at Captains Flat.

Next steps for the Former Station Master's Cottage

Demolition works are planned to occur by the first quarter of 2025. Timelines are yet to be confirmed.

As part of these works, Transport will:

- Finalise pre-works plans, (Safety Management Plan, Asbestos Removal Control Plan and Demolition Plan)
- Submit the SafeWork Notification
- Deliver remediation of the Site
- Complete validation and approval.

2024 calendar year

- Northern Dumps access road
- Relocation of site sheds
- Installation of soil and water management structures

2025 calendar year

- Opening of containment cell
- Lime treatment of soil and revegetation
- Encapsulation of soil in cell

2026 calendar year

- Closing of containment cell
- Demobilisation from site












Overview of lime treatment

Queanbeyan Palerang Regional Council Update:

Working with Department of Regional NSW to secure access to their waste cell for remediation of Council land, Council managed Crown Land and private land remediation projects.

Finalisation of plans for remediation of Foxlow Parklet, reinstallation of playground equipment and return of the park to the Captains Flat Community.





Tarago Rail Corridor Remediation Options Assessment (ROA)

Tarago Rail Corridor Remediation Options Assessment

- The Captains Flat community will be given the opportunity to give feedback on the Remediation Options Assessment for the Tarago Rail Corridor
- One of the preferred options is for Transport to take contaminated waste from Tarago to the Lake George Legacy Mine in Captains Flat.

Tarago Rail Corridor ROA – preferred option

Preferred options	Cost
Offsite containment at the Lake George Legacy Mine (preferred option)	Approx. 2.3 million dollars
Offsite disposal of unsegregated waste (second preferred option)	Approx. 6.2 million dollars

Transport have seriously considered the social, economic and environmental impacts of each option.

Tarago Rail Corridor ROA – preferred option

- The containment cell is scheduled to open in January 2025, for twelve months.
- It will take approximately 210 truck movements to remove 4650m3 of waste from Tarago.
- The containment cell can only take this specific type of contamination.
- It was designed to remediate the mine and has been redesigned to take in waste from Transport and Crown Lands.
- If the preferred option is approved, Transport will secure an agreement with Regional NSW.
