Plans to widen Heathcote Road between Princes Highway
and New Illawarra Road

Transport is progressing two key projects on Heathcote Road

We are developing designs to widen a section of the road to extend the westbound overtaking lane approaching New Illawarra Road to allow traffic to safely overtake slower vehicles.

This is part of a \$180 million NSW Government commitment to improve Heathcote Road between New Illawarra Road and Princes Highway.

The key benefits to the community of the upgrade include:

- increased road safety
- improved road network reliability allowing safe passing of broken-down vehicles
- decrease in traffic delays.

Transport is now understanding the landscape at the location of the new overtaking lane so we can prepare designs. You may see us out and about in the next few months as we conduct site investigations. We plan to consult the community in the first half of 2025 on a reference design for the overtaking lane.

We are also sharing details of a proposal to protect the koala population around Heathcote Road, particularly near Deadmans Creek.

To encourage koalas to travel away from the road and avoid passing vehicles, or only cross at safe locations, fencing is proposed along Heathcote Road which would result in continuous koala protection from Pleasure Point Road to south of St George Crescent.

We are also proposing installing one-way escape structures and improving fauna access under Deadmans Creek Bridge.

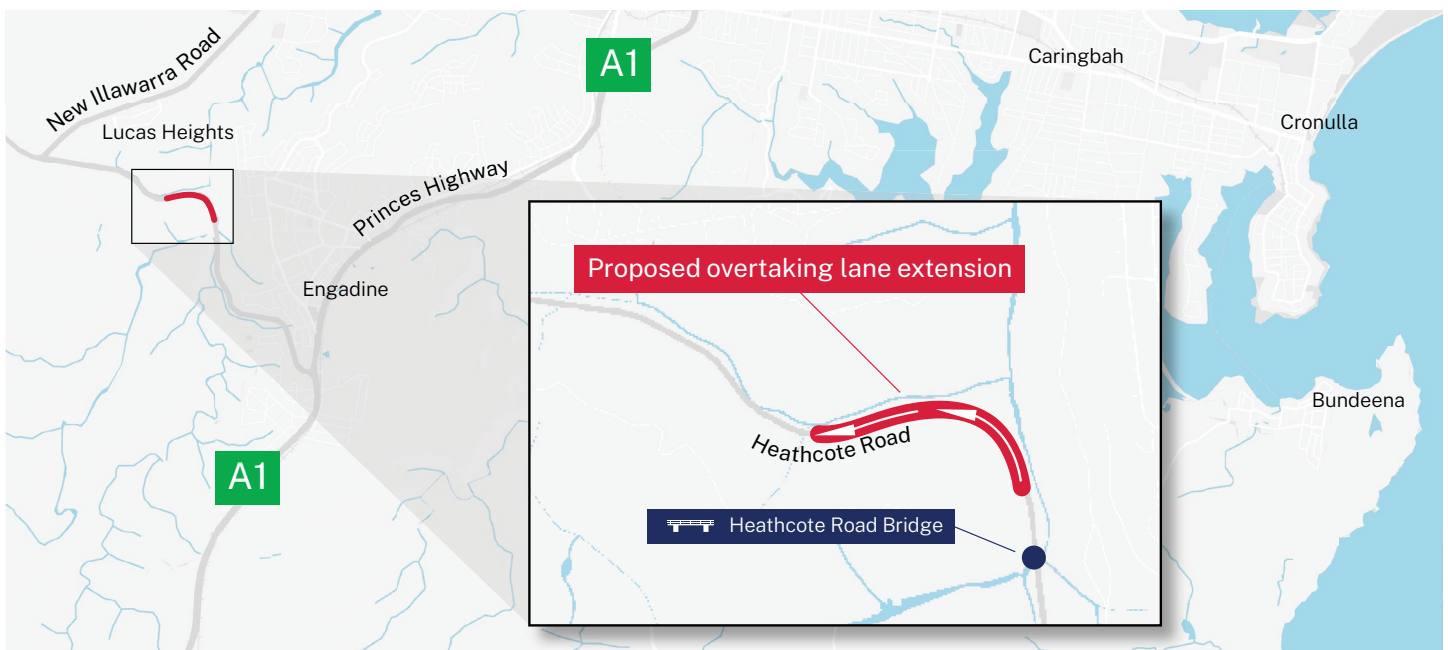
A Review of Environmental Factors (REF) has been prepared and the community and stakeholders are invited to provide feedback by **23:59pm Friday 13 December 2024**.

Environmental Impact Statement

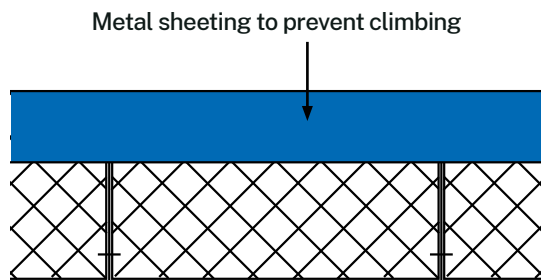
The construction of the Koala Fencing also impacts land classified as coastal wetlands, under the State Environmental Planning Policy (Resilience and Hazards) 2021. Under the State planning rules an Environmental Impact Statement (EIS) must be prepared when projects impact coastal wetlands. Transport have prepared an EIS which will be assessed and displayed by Liverpool City Council.

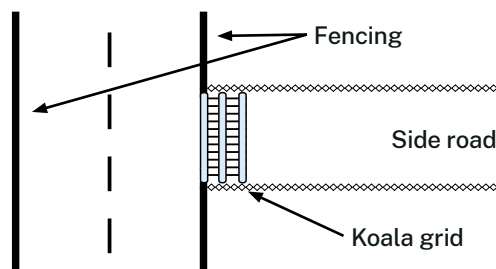
Map showing Heathcote Road overtaking lane



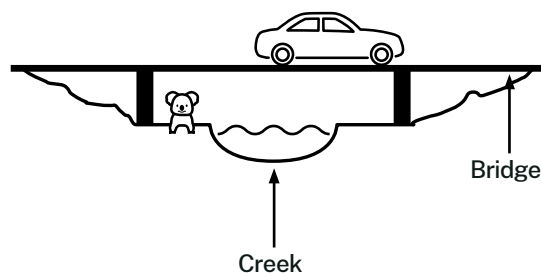
What koala protection measures are planned?



Installation of special fencing reduces koala vehicle strikes



Koala grids deter koalas from entering the road corridor at fence ends and are similar to cattle grids



Bridges and culverts provide opportunities for koalas to safely cross underneath the road

Koala fencing

Delivering continuous koala vehicle strike mitigation from Pleasure Point Road to south of St George Crescent, with over one kilometre of new koala fencing standing 1.5 metres high, with non climbable sheeting.

New fencing will connect with safe fauna crossing points, existing drainage culverts, Deadmans Creek Bridge; and Department of Defence fencing.

Koala grid

Installing a koala grid with pedestrian gate access on St George Crescent.

Fauna access

Installing one-way escape structures in the fence to allow koalas to get out of the road corridor if they become trapped.

Improving fauna access under Deadmans Creek Bridge including ground surface treatments and installation of refuge poles.

Vegetation removal

Selectively clearing up to three metres of vegetation on each side of the koala fencing, as required, for construction and to remove opportunities for koalas to climb the fencing.

Access improvement

Providing gates in the fence for emergency and maintenance access.

NSW Koala Protection

In NSW, vehicle strike is regarded as a key threat to koalas (Department of Planning, Industry and Environment, 2020), and is one of the most frequently reported causes of injury and death for koalas brought into care by wildlife rehabilitation groups.

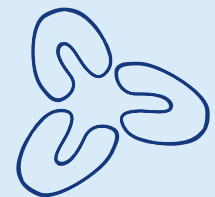
Transport is working with the Department of Climate Change, Energy, the Environment and Water (DCCEEW) to address koala vehicle strike along a one-kilometre section of Heathcote Road around Deadmans Creek, as part of the NSW Koala Strategy.

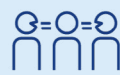
