Kingsgrove Bus Depot Conversion

Zero Emission Buses Program

Planning approval has been granted for the Kingsgrove Bus Depot Conversion.

In September 2024, Transport for NSW (Transport) approved the Kingsgrove Bus Depot Conversion, which is being delivered as part of the Zero Emission Buses Program.

A minor works Review of Environmental Factors (Minor Works REF) was prepared to describe the proposed work, assess the environmental impacts and to inform Transport's decision to proceed with the project.

About the project

Kingsgrove Bus Depot is being converted to zero emissions technology to support a new fleet of around 155 battery electric buses.

Key features of the project include:

- a new gantry with pull-down bus chargers and supporting charging technology
- removal of two existing sheds and trees within the depot
- decommissioning of existing fueling infrastructure

Work involved includes reconfiguring the bus parking layout and power supply upgrade.

Once the conversion is complete, the depot will operate an entire fleet of battery electric buses.

What are we doing?

From Tuesday 8 October 2024, our delivery partner Transit Systems, will start construction at Kingsgrove Bus Depot. Work activities to be completed over the coming months include:

- site establishment and laydown area within the depot
- demolishing an existing steel shade structure within the depot
- removal of trees between the staff car park and bus parking bays
- installation of charging technology and power supply infrastructure

The type of equipment used during this work includes:

- jackhammer
- chainsaw
- wood mulcher
- grinder
- crane
- excavators
- elevated work platforms
- trucks
- light vehicles

When and where we'll be working?

Construction work will be completed within the depot during standard construction hours (Monday to Friday 7am-6pm and Saturdays 8am-1pm).

Some work may be required outside of these hours and affected neighbours will be notified in advance of any work outside these times.

Temporary parking changes

Up to 13 staff car parking spaces will be temporarily impacted during this work. Alternative staff parking has been arranged on-site in another location of the depot during this time.

This is to enable a construction laydown area and the safe removal of existing trees and infrastructure within the depot.

What will this mean for you?

There will be some noise associated with the work activities. We will take every step to reduce noise impacts on the community and the environment. This includes and is not limited to:

- using non-tonal reversing beepers
- instructing workers to keep noise to a minimum
- using noise blankets
- not leaving machinery and equipment idling when not in use.

We will continue to keep the community updated as construction progresses.
